

RESOLUTION NO. _____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, APPROVING THE RECOMMENDATIONS OF THE CITY OF MESA REDISTRICTING COMMISSION REGARDING THE ESTABLISHMENT OF CITY OF MESA CITY COUNCIL DISTRICT BOUNDARIES ACCORDING TO THE 2020 UNITED STATES DECENNIAL CENSUS.

WHEREAS, pursuant to Section 201(A) of the Mesa City Charter, the Mesa City Council appointed a five person nonpartisan Redistricting Commission to redraw the Mesa City Council district boundaries according to the 2020 United States Decennial Census.

WHEREAS, the Redistricting Commission held seven Redistricting Commission meetings, seven community outreach meetings, and provided numerous other opportunities to the citizens of Mesa to provide input and submit proposed Mesa City Council district boundary maps to the Redistricting Commission.

WHEREAS, the Redistricting Commission reviewed and considered the public input and proposed Mesa City Council district boundary maps submitted by the citizens of Mesa.

WHEREAS, Redistricting Partners, a redistricting consulting firm, was retained by the City of Mesa to assist the Redistricting Commission in redrawing the Mesa City Council district boundaries.

WHEREAS, pursuant to Section 201(A)(3) of the Mesa City Charter, on October 26, 2021, the Redistricting Commission approved new Mesa City Council district boundaries according to the 2020 United States Decennial Census to recommend to the Mesa City Council.

WHEREAS, the Mesa City Council has reviewed the Redistricting Commission's recommended new Mesa City Council district boundaries and finds the new boundaries serve the best interests of the citizens of Mesa.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

Section 1: The Redistricting Commission's recommended Mesa City Council district boundaries, attached hereto and incorporated herein as Exhibit A, are approved.

Section 2: The City Manager, or his designated representative, in conjunction with the Redistricting Commission, is hereby authorized and directed to perform all necessary acts to give effect to this Resolution, and the City Clerk is authorized and directed to attest to the signature of the City Manager, or his designated representative thereon.
