Good morning Roxana,

On behalf of the Board of Directors of the Arizona Sports and Tourism Authority (AZSTA), we are pleased to inform you that your 2018 Biennial Grant request has been approved. AZSTA will be awarding a grant to the City of Mesa in the amount of \$49,345.20 for the grant project submitted in your application. A formal letter will be sent tomorrow.

As indicated in the grant application, awards cannot exceed 2/3 of the cost of the project. AZSTA will require a final budget submitted with the funding agreement. A reduction in the project costs will reduce the Authority contribution on a pro-rata basis. An increase in the project costs will not increase the Authority contribution but will be an obligation of the recipient.

In the next few weeks, you will receive a funding agreement from AZSTA. In the meantime, please contact Robin Lea-Amos at robin@az-sta.com with any questions. It is important to note that your project cannot begin until the funding agreement is fully executed.

Also, please save the date for the Grant Reporting and Management Workshop, to be held Friday, November 17, 2017 at University of Phoenix Stadium. Attendance is required for all AZSTA Grant Award recipients. We will provide detailed information in the coming weeks.
