Subject: Four-Year Term Contract with Renewal Options for Childhood and Adult Vaccines for the Mesa Fire and Medical Department (**\$100,000 funded by the Salt River Pima - Maricopa Indian Community Grant** and **\$10,000 grant funded by the Arizona Department of Homeland Security**) (Citywide)

Recommendation

Council is requested to approve the award as recommended.

The Mesa Fire and Medical Department and Purchasing recommend authorizing the purchase using the Minnesota Multistate Contracting Alliance for Pharmacy (MMCAP) cooperative contract with multiple vendors: GlaxoSmithKline, LLC, McKesson Corporation dba, Sky Packaging, Merck Sharp & Dohme Corp., Sanofi Pasteur, Inc., at \$110,000 annually, based on estimated usage.

Background / Discussion

The Mesa Fire and Medical Department (MFMD) Immunization Program purchases vaccines from several different vendors. The Minnesota Multistate Contracting Alliance for Pharmacy (MMCAP) cooperative agreement provides vaccines and other pharmaceuticals including, Influenza, Tuberculin skin tests, Pertussis (Tdap), Measles, Mumps, Rubella (MMR), Varicella, and Hepatitis B and Hepatitis A for their Childhood Immunization Program.

The MMCAP cooperative agreement provides special pricing that would not otherwise be made available by the vendors individually. MFMD is requesting approval for a four-year term coinciding with the MMCAP contracts' terms (7/1/2020 to 6/30/2024). Approval of the initial four-year term will provide efficiencies in renewing the City's contract concurrent with MMCAP's annual renewal.
