Subject: Purchase of One Water Tanker/Tender (Replacement) for the Mesa Fire and

Medical Department (Funded by 2018 Public Safety Bonds) (Citywide)

Purpose and Recommendation

Council is requested to approve the award as recommended.

The Mesa Fire and Medical Department and Purchasing recommend authorizing the purchase using the Sourcewell cooperative contract with H & E Equipment Services at \$511,850.

Background / Discussion

This purchase is for one 2022 water tanker/tender that will replace a 1995 water tanker/tender as part of the ongoing apparatus replacement schedule. The unit that is being replaced has met the established criteria and will be sold by a sealed bid process.

MFMD has allocated budget for replacement fire apparatus in their Capital Improvement Plan:

FY 18/19 – \$6.4M (actuals) – 1 Pumper, 4 Ladders

FY 19/20 - \$4.7M (actuals) - 5 Pumpers

FY 20/21 – \$4.4M - 4 Pumpers (Council awarded 2/22/2021)

FY 21/22 – \$3.12M – 1Tanker (This Purchase), 2 Pumpers (Council awarded 10/18/2021)

FY 22/23 - \$3.6M - 3 Pumpers

FY 23/24 - \$2.5 M - 2 Pumpers

The Sourcewell cooperative contract has been competitively bid and meets the City's procurement requirements. Using this cooperative contract provides the City leveraged pricing based on an aggregate regional solicited agreement.
