# **Purpose and Recommendation**

The purpose of this report is to provide the City Council with a recommendation regarding adding new and revising current fees and fines at the Mesa Public Library to be more consistent with area libraries and generate revenue to help offset some of the cost of the service. After researching and comparing the Mesa Public Library with other area libraries the following are recommended:

# Background

- Library Hold Not Picked Up (after 7 days): As a new fee instituted in 2005, the library currently charges \$0.50 for holds not picked up after seven days. The library is proposing an increase to \$1.00 for this fee based on comparisons with other libraries.
- **Earbuds:** As a new fee instituted in 2009, the Library currently charges \$5.00 to purchase a set of earbuds. The library is proposing a decrease for this fee to \$2.00 based on comparisons with other libraries.
- Library Daily Overdue Fines Other Materials \$1.00 per day: As a proposed new fee other materials include but are not limited to engravers, SRP energy meters, Nooks and book discussion kits. The library is proposing a fee of \$1.00 per day for other materials although currently no comparison data with other libraries is available.

- Reusable Shopping Bags: As a proposed new fee, the sale of reusable shopping bags would benefit the libraries customers and serve as a marketing tool for the library. The library is proposing a fee of \$2.00 per bag based on comparisons with other libraries.
- Interlibrary Loan Not Picked Up: As a proposed new fee, Interlibrary Loan is a service whereby customers may borrow an item from another library system. The library is proposing a fee of \$2.00 per item based on comparisons with other libraries.
- **3D Printing:** As a proposed new fee, 3D printing is a service available at THINKspot at the Red Mountain Library. The library is proposing a fee of \$0.05 per gram based on comparisons with other libraries.

#### **Discussion**

It is important that we not penalize people unfairly for not returning items but it is also imperative that we remain fiscally responsible to the taxpayers of Mesa. As part of the budgeting process, Library Administration surveyed area libraries for their fees and fines schedules and the proposed changes were developed. The recommendations, if approved, will bring the Mesa Public Library fees and fines schedule in line with other area libraries, and generate some additional revenue to cover the cost of the service. #### **Alternatives**

The fees and fines schedule could remain the same as it is now. No additional revenue to help cover costs of providing library services would be realized.

#### **Fiscal Impact**

It is projected that the increases recommended would result in additional revenue of \$14,940. The staff time for processing these added service transactions would be negligible. (See Attachment A)
