On September 26, 2022, a Design Review Board Notification letter was sent to a list of sixteen (16) addresses business and residential parcels within 500' of the proposed Wall Company project located at 6447 South Mountain Road. The Design Review Board meeting was held on October 11, 2022.

Archicon did not receive any telephone calls or electronic messages expressing any concerns from any of the sixteen (16) businesses and residences on the mailing list.

Similarly, on November 1, 2022, a Planning and Zoning Review notification letter was prepared and delivered to the City of Mesa. Having been postponed to the Planning and Zoning Review meeting to be held on December 16, 2022, the letters were left in possession of the Planning and Zoning Department.
