Subject: Three-Year Term Contract with Two-Year Renewal Options for Masonry Wall

Cleaning Painting and Repair Services for the Transportation Department

(Citywide)

Recommendation

Council is requested to approve the award as recommended.

The Transportation Department and Procurement Services recommend Primary, Secondary, and Tertiary awards to the lowest, responsive, and responsible bidders, Fabiani Painting and Decorating (a Mesa business), A & H Painting, and Ghaster Painting & Coatings at \$154,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

Background / Discussion

This contract provides masonry wall cleaning, painting, and repair services to maintain the appearance and integrity of various walls located within the City of Mesa's right-of-way. Routine cleaning and painting are essential to preserve their visual appeal, and minor repairs may be necessary prior to painting. Additionally, the contract includes provisions for emergency repairs. To ensure prompt response in urgent situations, the contract is being awarded to a primary, secondary, and tertiary contractor, guaranteeing availability for timely property damage restoration.
