**Subject:** Award of Additional Vendors to the Three-Year Term Contract with Two

Years of Renewal Options for Off Site Vehicle Washing Services for Citywide

Departments (Citywide)

#### Recommendation

Council is requested to approve the award as recommended.

A committee representing the Police, Fleet Services and Mesa Fire and Medical Departments and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the qualified proposals from Raceway Carwash dba, Mesa Dr Carwash LP, Alma School Rd Carwash LP, Gilbert Rd Carwash LP, Power Rd Carwash LP, Warner Rd Carwash LP; TNS Enterprises dba, Campbell's Carwash (a Mesa business); and Yuyin Detail, LLC (a Mesa business); at \$47,500 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

#### **Background / Discussion**

City of Mesa has a fleet consisting of a variety of vehicles, including sedans, vans, and trucks. This contract will provide a listing of qualified vendors and approved car wash facilities for off-site vehicle washing services (Basic Vehicle Washing packages 1, 2 and 3) on an as-needed basis. These qualified vendors have a vehicle washing facility or mobile service located within Mesa and all the necessary equipment, items, supplies, expertise, personnel and insurance necessary to provide off-site vehicle washing services.

The City solicitated Request for Qualifications (RFQs) due on May 4, 2020, re-solicited for RFQs due June 1, 2020 to determine if any additional carwash vendors could be added to the contract that Council awarded on 8/24/2020.

The City solicited the final solicitation (Re-Solicitation No. 2) for RFQs due January 25, 2021, to determine if any additional carwash vendors could be added to the contract (See January 25, 2021 Proposal Responses). The City received four proposal responses of which, three met the minimum qualifications and one was deemed as non-responsive (Glanos Hydro Dynamic LLC). The evaluation committee evaluated the proposals in accordance with the City's established policies and procedures and completed the final scoring against the scoring criteria in Re-Solicitation No. 2. The evaluation was conducted, and points were awarded by consensus by the evaluation committee to the qualified proposals from Raceway Carwash dba, Mesa Dr Carwash LP, Alma School Rd Carwash

LP, Gilbert Rd Carwash LP, Power Rd Carwash LP, Warner Rd Carwash LP; TNS Enterprises dba, Campbell's Carwash (a Mesa business); and Yuyin Detail, LLC (a Mesa business).
