

**RESOLUTION NO. 12528**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA MODIFYING FEES AND CHARGES FOR THE COMMUNITY SERVICES DEPARTMENT, BUSINESS SERVICES DEPARTMENT, MESA FIRE & MEDICAL DEPARTMENT, AND MESA POLICE DEPARTMENT.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA, AS FOLLOWS:

Section 3: The various City officers and employees are hereby authorized and directed to perform all acts necessary to give effect to this Resolution.
