

RESOLUTION NO. 12431

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA APPROVING AND AUTHORIZING THE CITY MANAGER TO ACCEPT PROPOSITION 202 FUNDS FROM THE SALT RIVER PIMA-MARICOPA INDIAN COMMUNITY AND ADMINISTER AWARDED FUNDS AS PASS-THROUGH GRANTS TO DESIGNATED AWARDEES.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA AS FOLLOWS:

Section 1: Arizona's Indian Gaming Compact provides that an Indian Tribe make twelve percent (12%) of its net annual State contribution to cities, towns or counties for government services that benefit the general public. Private, not-for-profit organizations wishing to access Indian Gaming Funds ("Gaming Funds") to provide public benefits must secure sponsorship from a city, town or county before making application. This sponsorship must be expressed in a resolution passed by the local government sponsor.

Section 2: The Salt River Pima-Maricopa Indian Community wishes the City of Mesa to receive and distribute **\$1,615,000.00** from its 12% revenues for grants as follows:

- \$300,000.00 to the **City of Mesa** for four governmental programs.
- \$200,000.00 to **A New Leaf** for Emergency homeless and domestic violence shelter service programs.
- \$ 50,000.00 to **U.S. Vets – Phoenix** to support mental health services for homeless and at-risk veterans. Funding would be used to expand services in Maricopa County.
- \$ 100,000.00 to the **Child Crisis Center** for the Family Education and Resource Distribution Center to provide families with the support and resources they need to improve family stability and wellness.
- \$ 50,000.00 to **Alice Cooper's Solid Rock Teen Center** for the Play Ball, physical fitness for non-athletic youth program to improve the health of youth.
- \$ 20,000.00 to **Visit Mesa** for the Allegiant Non-stop flight markets campaign.
- \$175,000.00 to the **United Food Bank** for the Emergency Food Assistance Produce Box Program.
- \$100,000.00 to the **Paz De Cristo** for relief services to empower individuals that include: food assistance, clothing, and empowerment services.
- \$200,000.00 to the **Arizona Museum of Natural History** for the Mobile Exploration and Discovery (MEAD) program to provide hands on science and literacy

education.

- \$ 30,000.00 to **First Tee Phoenix** for the On Course, School, and Community Outreach programs to enhance youth development.
- \$300,000.00 to the **Mesa Public Schools** for the Pathway to Success: Continuing the journey of empowering students through community partnerships.
- \$ 40,000.00 to the **Strong Enough Boxing Club** for the Strong Enough to lead: Youth Boxing and character program.
- \$ 50,000.00 to **A Mighty Change of Heart** for personalized support for Foster/Kinship Children in Arizona.

Section 3: The City Council supports these grants and authorizes the City Manager, or his designee, to accept and administer the awarded Salt River Pima-Maricopa Indian Community Proposition 202 funding.

Section 4: Approval by the City Attorney or designee and signature by the City Manager or designee of the Intergovernmental Agreement, and any related amendments or supplements thereto, shall constitute conclusive evidence of this City Council's approval thereof.
