**Subject:** Use of a Cooperative Contract for the Purchase of Three (3) Slurry Seal Trucks (Two Replacements/One Addition) for the Transportation Department  
**(Local Street Sales Tax) (Citywide)**

## Purpose and Recommendation

Fleet Services, the Transportation Department, and Procurement Services recommend authorizing the purchase using the Sourcewell cooperative contract with Rush Truck Centers of Arizona dba Rush Truck Center Phoenix at \$2,107,585.71, based on estimated requirements.

## Background / Discussion

This purchase will provide a total of three (3) Slurry Seal Trucks (two replacements and one addition). The two replacements will replace older slurry trucks that have reached the end of their useful life. The purchase of the one addition ensures the City will have adequate spares needed to support Transportation's pavement preservation maintenance program.

The Sourcewell cooperative contract has been competitively bid and meets the City's procurement requirements. Utilizing the Sourcewell contract allows the City to receive competitive rates based on a nationally solicited agreement. The City believes the price is fair and reasonable and soliciting for this product would not result in the City receiving more favorable pricing, terms, or competition. The local distributor, Rush Truck Centers, has confirmed that the Sourcewell contract offers the largest discount available on a cooperative contract for the purchase of these specific vehicles.
