AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA, AMENDING SECTIONS 10-4-3, 10-4-4, 10-4-5 AND 10-4-6 OF THE MESA CITY CODE PERTAINING TO SPEED LIMITS WITHIN THE CITY LIMITS ON MAIN STREET; PROVIDING FOR SEVERABILITY; AND PROVIDING CIVIL SANCTIONS FOR THE VIOLATION THEREOF.

THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Mesa, Maricopa County, as follows:

Text written in **BOLD ALL CAPS** indicates new language.

Strikethrough fonts indicate deletions.

<u>Section 1:</u> That Section 10-4-3 of the Mesa City Code is amended by changing the following provision in alphabetical order and thereby describing streets on which a person shall not exceed a speed of forty-five (45) miles per hour:

Main Street	From a point two hundred eleven feet (211') east of Gilbert Road
	GILBERT ROAD to the east City limits;

<u>Section 2:</u> That Section 10-4-4 of the Mesa City Code is amended by changing the following provision in alphabetical order and thereby describing streets on which a person shall not exceed a speed of forty (40) miles per hour:

Main Street	From a point fifty-three feet (53') west of South Allen Street to a point two hundred eleven feet (211') east of Gilbert Road;
	two numerica cieven rect (211) cast of Chibert Road,
	From the west City limits to Alma School Road

<u>Section 3:</u> That Section 10-4-5 of the Mesa City Code is amended by changing the following provision in alphabetical order and thereby describing streets on which a person shall not exceed a speed of thirty-five (35) miles per hour:

Main Street	From a point fifty-three feet (53') west of South Udall Street MESA
	DRIVE to a point fifty-three feet (53') west of Allen Street GILBERT
	ROAD;
	From Alma School Road to Country Club Drive

<u>Section 4:</u> That Section 10-4-6 of the Mesa City Code is amended by changing the following provision in alphabetical order and thereby describing streets on which a person shall not exceed a speed of thirty (30) miles per hour:

Main Street , East	From Centennial Way/Sirrine to a point fifty-three feet (53') west of
	South Udall Street MESA DRIVE;

<u>Section 5:</u> Severability. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance or any part of the material adopted herein by reference is for any reason held to be invalid or unconstitutional by the decision of a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

<u>Section 6:</u> Civil Traffic Violations: Any violation of or failure or refusal to do or perform any act required by the provisions of this ordinance or of the Mesa City Code as amended herein shall constitute a civil traffic violation and be subject to the provisions of Title 10, Chapter 7 of the Mesa City Code.
