**Subject:** Purchase of Replacement/Upgrade Equipment for the TOPAZ Regional Wireless Cooperative (TRWC) for the Information Technology Department  
**(Funded by TOPAZ Joint Venture Fund) (Citywide)**

## Recommendation

Council is requested to approve the award as recommended.

The Information Technology Department and Purchasing recommend authorizing the purchase from the State of Arizona cooperative contract with Motorola Solutions, Inc., for \$208,531.00 plus contingency funding of \$61,469.00, for the total amount of \$270,000.00.

## Background

The TOPAZ voice radio network is utilized by Public Safety and other City Departments serving the City of Apache Junction, Fort McDowell Yavapai Nation, Town of Gilbert, City of Mesa, Town of Queen Creek, and the Superstition Fire & Medical District.

The Florence Gardens radio site was added to the TRWC network to provide service for the Mesa Energy Resources Magma Gas Service Area. This radio site also provides vital communications for the Apache Junction and Mesa Police Departments when transporting prisoners to the correctional facilities located in the Town of Florence. The equipment located at the Florence Gardens radio site is obsolete and is no longer supported by the manufacturer.

The State cooperative contract for Motorola has been competitively bid and provides for the lowest possible cooperative pricing. Going out for a formal bid would only delay the project and would not result in any cost savings to the City.
