**Subject:** Three-Year Term Contract with Two Years of Renewal Options for Traffic Signal Equipment Painting Services for the Transportation Department  
**(Funded by Local Streets Fund) (Citywide)**

## Recommendation

Council is requested to approve the award as recommended.

A committee representing the Transportation Department and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the highest-scored proposal from OLS Restoration, Inc. at \$235,000 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

## Background / Discussion

The contract will provide painting services for the City's traffic signal poles, cabinets, and signal heads for the Transportation Department. The City refinishes each of the traffic signalized intersections on an eight (8)-year cycle. The City has approximately 500 traffic-signalized intersections. The Contractor is required to supply all materials, labor, and temporary traffic control (barricading).

Refinishing of traffic signal equipment is necessary to protect metal from rust and corrosion. Refinishing also extends the life of the traffic signal equipment. Traffic signal heads become less visible as the original black color fades or bare metal becomes exposed. Painting traffic signal heads provides adequate contrast needed for visibility. Refinishing equipment helps reduce the cost of equipment replacement.

The City solicited Request for Proposals and received five (5) responses which all met the minimum qualifications. The evaluation committee evaluated the responses relative to the scoring criteria in the solicitation and completed scoring the responses in accordance with the City's established policies and procedures. Based on the evaluation results, award is recommended to the respondent with the highest score.
