June 29, 2023

The City Council of the City of Mesa met in a Study Session in the lower-level meeting room of the Council Chambers, 57 East 1st Street, on June 29, 2023, at 7:38 a.m.

Mayor Giles conducted a roll call.

1. Review and discuss items on the agenda for the July 3, 2023, Regular Council meeting and Special Council meeting.

All of the items on the agenda were reviewed among Council and staff and the following was noted:

Items removed from the Consent Agenda: 4-I

In response to a question by Councilmember Duff regarding Item 4-c, (Upgrade of the City's Existing Capital Improvement Program (CIP) Project Management Solution for the Engineering Department (Sole Source) (Citywide)), City Engineer Beth Huning explained that the system upgrade will move the project management software into one platform. She said that staff will continue to work with the existing contracted company while making customizations to meet the needs of the department and the citizens.

In response to a question by Councilmember Spilsbury relative to Item 4-b, (Central Mesa Reuse Pipeline - Construction Manager at Risk (CMAR), Guaranteed Maximum Price (GMP) No. 2 (District 2)), Ms. Huning said that the GMP marks the official start of the Central Mesa Reuse Pipeline project explaining that the construction will be done in phases beginning on July 24.

In response to a question by Councilmember Somers regarding Items 6-c, (ANX23-00215 "Power Road Right-of-Way De-Annexation" (District 6)), 7-a, (ZON22-01340 "Residences at Dobson and Cubs Way" (District 3)), and 7-b, (ZON22-01344 "La Mesita - Phase 4" (District

- **3))**, Assistant Planning Director Rachel Nettles confirmed the projects noted have been reviewed by the Design Review Board and meet the City's form-based code and all design standards.
- 2-a. Hear a presentation, discuss, and provide an update on a proposed citywide program for Mesa faith-based organizations to collaborate and collectively serve the needs of our community, "Together In Service".

Director of Diversity and Engagement Andrea Alicoate introduced Deputy Director Community Services Lindsey Balinkie and displayed a PowerPoint Presentation. (See Attachment 1)

Ms. Alicoate provided an update on a proposed citywide program for Mesa faith-based organizations to collaborate and collectively serve the needs of our community. She said that the program was launched last year as a commitment to represent our community, Together in Service. She gave an overview of the program and explained how the program pillars support the initiative. (See Pages 2 through 5 of Attachment 1)

Ms. Balinkie presented the program structure and explained how the Community Services and Engagement division will provide staffing support for this model. She explained that the City launched a needs survey for feedback from the faith-based organizations and the data will be reviewed at the next quarterly network meeting. She stated that a registry and map of the faith-based organizations has been created to easily locate services. (See Pages 6 through 8 of Attachment 1)

Ms. Alicoate reviewed the program launch timeline. (See Page 9 of Attachment 1)

Mayor Giles thanked staff for the presentation.
