

**ORDINANCE NO. 5836**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA  
ADOPTING TITLES AND SCHEDULES OF TERMS, RATES, FEES AND CHARGES  
FOR CITY-OWNED SOLID WASTE UTILITIES**

BE IT ORDAINED by the City Council of the City of Mesa, Maricopa County, State of Arizona, as follows:

Section 1: That the following Titles and Schedules of Terms, Rates, Fees and Charges for City-Owned Solid Waste Utilities, as made public record by Resolution adopted on November 20, 2023, three copies of which are on file and available for public use and inspection with the Office of the City Clerk, are hereby established or amended and adopted to be applicable for monthly billing cycles commencing on and after the effective date of this Ordinance:
