## **RESOLUTION NO. 12433**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, ADOPTING THE "DOWNTOWN MESA MICROMOBILITY & PARKING PLAN" AS A GUIDING DOCUMENT REGARDING MICROMOBILITY AND PARKING CONDITIONS AND GOALS FOR DOWNTOWN MESA.

Whereas, the Central Main Plan, adopted by the City Council on January 23, 2012, creates a development vision and goal for Downtown Mesa to facilitate economic development, including leveraging a high-quality, efficient, multi-modal transportation network to support the success of existing and future businesses and attractions.

Whereas, the Mesa 2050 General Plan, adopted by the City Council on May 20, 2024, and approved by Mesa voters on November 5, 2024, sets goals and priorities for Downtown Mesa, including encouraging the development of vibrant activity centers and an efficient, safe, and well-connected transportation system that includes continued investment in innovative transportation technologies, integrated micromobility pathways, and well-planned parking.

Whereas, the City and the Micromobility and Parking Plan Advisory Committee (the "Committee"), comprised of City staff and non-profit representatives, guided the creation of the "Downtown Mesa Micromobility & Parking Plan" dated October 2025 (the "Plan") in order to support the continued transformation of Downtown Mesa, including to make Downtown Mesa more walkable, encourage a park-once mentality, and promote a safe and interesting walk or roll to move around Downtown Mesa, and to further support the goals and priorities for Downtown Mesa included in the Central Main Plan and the Mesa 2050 General Plan.

Whereas, in preparing the Plan, the City conducted public outreach and incorporated feedback from residents and businesses in Downtown Mesa and its surrounding areas and received and incorporated direction from the Committee.

Whereas, the City Council desires to adopt the Plan as a guiding document regarding micromobility and parking conditions and goals for Downtown Mesa.

Now therefore, be it resolved by the City Council of the City of Mesa, Maricopa County, Arizona, as follows:

<u>Section 1</u>: The Downtown Mesa Micromobility & Parking Plan dated October 2025 is hereby adopted as a guiding document regarding micromobility and parking conditions and goals for Downtown Mesa.

<u>Section 2</u>: The City of Mesa officers and employees who respond to micromobility and parking conditions in Downtown Mesa are hereby authorized to take such actions as are appropriate to consider and use the guidance outlined in the Downtown Mesa Micromobility & Parking Plan dated October 2025.
