#### 1. Call Meeting to Order.

Chair Babos declared a quorum present. The meeting was called to order at 5:02 pm. The chair then read the following statement:

"The City of Mesa acknowledges that we gather on the homeland of the Native people and their ancestors, who have inhabited this landscape from time immemorial to the present day. The landscape is sacred and reflects cultural values central to the O'odham (Pima) and the Piipaash (Maricopa) way of life and their self-definition. This acknowledgment demonstrates our commitment to work in partnership with Ancestral Indigenous Communities to foster understanding, appreciation, and respect for this heritage."

### 2. Approval of the minutes from the <u>August 6, 2024</u> Historic Preservation Board meeting.

### 3. Introduce Abraham Arnett – City of Archaeologist

City Archaeologist, Abraham Arnett shared his extensive experience in archaeology. He highlighted his work in Arizona, including archaeological surveys, excavations, monitoring, full data recovery and cultural resource compliance.

### 4-a. Discuss the January 2025 Mesa Historic Preservation Board Retreat and potential topics for the retreat.

Historic Preservation Officer, Matthew Kriegl requested topics for the retreat.

## 4-b. Discuss the May 2025 Historic Preservation Month Essay and Visual Arts contest and potential essay and visual arts contest topics.

Chair Babos requested this agenda item be continued until next month to give Board members time to think about potential topics. He suggested adding a future agenda item to consider changing the date of this event to earlier in the year so winter visitors may attend. Staff was requested to identify the popular topics selected by last year's participants.

## 4-c. Hear an update from City staff regarding the Downtown Façade Improvement Project.

### Summary:

Jeff McVay, Manager of Downtown Transformation, Anthony Rodriguez, Downtown Transformation Project Manager, and Bryce Albretsen, Engineering Sr. Civil Engineer displayed a PowerPoint presentation highlighting details of four specific project locations. (see attachment 1)

In response to a question from Chair Babos, Mr. Kriegl clarified the projects do not have to meet specific guidelines and these buildings are not currently part of any Historic District.

During discussion the Board expressed interest in recognizing historical events and people associated with the buildings. Staff acknowledged the importance of preserving as much historic material as possible and the potential for Historic District designation.

After some discussion by the Board and staff, Mr. Kriegl assured the Board as much historic material will be preserved as possible so as to not diminish any chance of historic designation in the future. He also discussed the challenges of maintaining historic integrity while ensuring functionality of the buildings.

Chair Babos encouraged staff to consider the impact of signage on the esthetics of the façade improvement projects.

In response to questions posed by Chair Babos, Mr. McVay stated the wood beams to be installed at 104 W Main St. will require maintenance. He also shared there is a proposed neon art feature, details not yet determined, that will replace the current sign at that location.

The windows as well as other features of the 136 W Main St. building were discussed in more detail. Staff explained the difficulties in restoring this location as it has been remodeled several different times affecting some of the historic features.

### 5. Hear reports from Board Members of current events and educational topics related to historic preservation.\*\*

There were no updates on this item from Board members.

### 7. Historic Preservation Officer's Updates.\*

Mr. Kriegl welcomed new City Archaeologist, Abraham Arnett stating he is excited to work together with Mr. Arnett and to have someone to help with archaeology in the City of Mesa.

- Will incentivize new tenant opportunities





- Restore historic character to one of the oldest buildings in downtown Mesa




