**Subject:** Use of a Cooperative Contract for a Two-Year Term and Renewal Options for

IDEMIA LiveScan Workstations and Equipment (Replacement) for the Mesa

Police Department (Sole Source) (Citywide)

## **Purpose and Recommendation**

Council is requested to approve the award as recommended.

The Police Department and Purchasing recommend authorizing the purchase using the State of Arizona cooperative contract with Morpho USA, Inc./IDEMIA at \$100,000 annually, based on estimated requirements.

#### **Background / Discussion**

In 2004, the Police Department purchased these types of machines, and replaced them in 2012. Since that time, the Police Department has been using IDEMIA equipment which is essential to the booking process, identification purposes, and other criminal justice functions. The current software used in these machines will no longer be supported by Arizona Department of Public Safety (AZDPS). AZDPS has only approved IDEMIA software to capture photos and communicate with law enforcement agencies.

IDEMIA provides a fully integrated LiveScan solution including an AFIS interface, digital image captures, is fully compliant with AZ-DPS AFIS, FBI IAFIS/NGI EBTS and ANSI/NIST image standards.

The initial purchase will be three LiveScan workstations for the Holding Unit in the amount of \$58,725.68. The Department has requested additional capacity to purchase more units as funds are identified.

The State of Arizona, Department of Public Safety has an active cooperative contract to purchase this equipment. It has been competitively bid, meets City procurement requirements and using this contract is in the best interest and advantageous for the City.
