Curb appeal/aesthetics: Open parking in front, does have alley access and open space for vehicles in back yard.

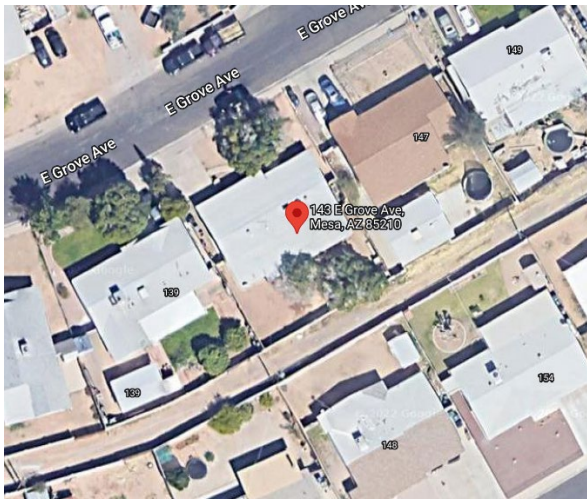

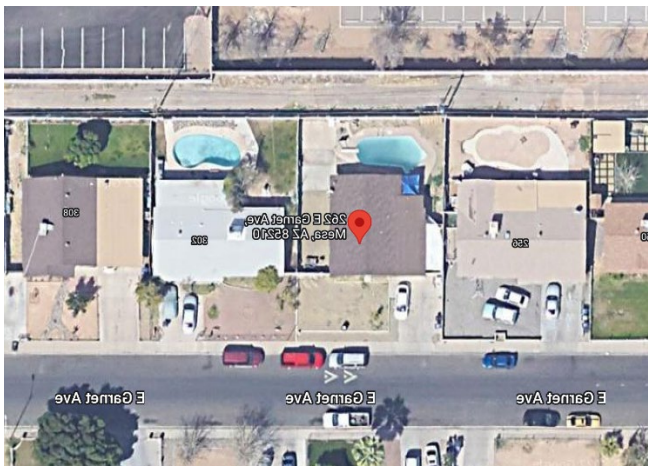

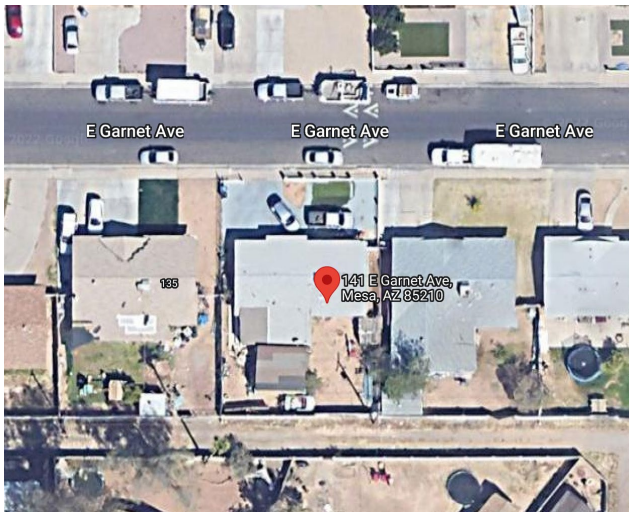

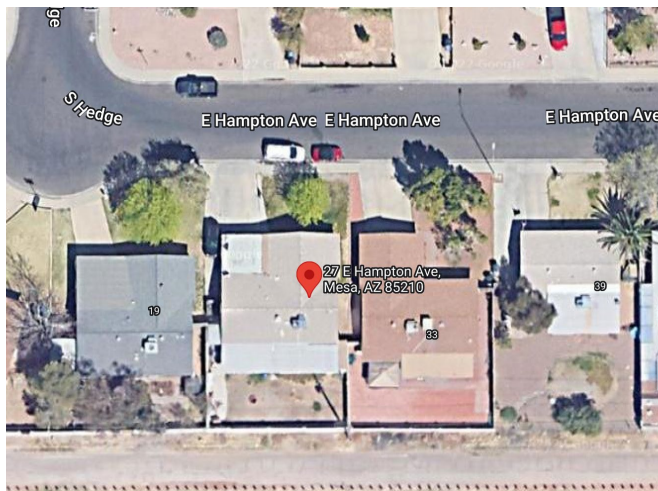
