**Subject:** Dollar Limit Increase to the Cooperative Contract for a Six-Year Service and Capital Expenditure Agreement for Motorola System Upgrade II (SUA II) for the TOPAZ Regional Wireless Cooperative (TRWC) as requested by the Department of Innovation and Technology (Sole Source) **(Citywide)**

## Recommendation

The Department of Innovation and Technology (DoIT) and Procurement Services recommend increasing the dollar limit with Motorola Solutions, Inc., by \$665,100 from \$12,647,700 to \$13,312,800 for the remaining term of the contract.

## Background / Discussion

The Motorola System Upgrade Agreement II (SUA II) provides annual software upgrades, upgrades to the network core hardware to support the software upgrades, and technical support services for the TOPAZ (TRWC) Public Safety voice two-way radio network.

DoIT is requesting an increase to incorporate the 800 MHz 6-Channel ASTRO Standalone Repeater Site (ASR) add-on to the TOPAZ Regional Wireless Cooperative (TRWC) ASTRO 25 Network. The project will provide better signal acquisition and coverage for first responders utilizing the network. Also, these improvements will allow the site to minimize downtime from failure, maintenance, or site updates. The scope of this increase includes the pricing for the licensing, radio frequency and fault management equipment for the project. The City of Mesa is the Administrative Manager for the TRWC. Costs are shared among the TOPAZ members.
