#### **RESOLUTION NO. 12440**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, CANVASSING, DECLARING AND ADOPTING THE RESULTS OF THE SPECIAL RECALL ELECTION HELD ON NOVEMBER 4, 2025.

WHEREAS, pursuant to Resolution 12400, the City of Mesa, Maricopa County, Arizona, held a special recall election on the 4<sup>th</sup> day of November 2025 for the recall of District Two Councilmember Julie Spilsbury.

WHEREAS, the recall matter was put before the voters in District Two of the City of Mesa, Arizona as a ballot-by-mail election performed by Maricopa County elections officials on November 4, 2025.

WHEREAS, the election returns were certified by the Maricopa County Election Director and Maricopa Recorder, a true and correct copy of the certification is attached hereto as <u>Exhibit A</u> and is incorporated herein by this reference (the "<u>Certification of Election Returns</u>").

WHEREAS, the election returns have been presented to the City Council which is required by law to canvass the results not less than six days and not more than twenty days following the election pursuant to Arizona Revised Statutes §§ 16-642 and 16-646.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

Section 1: The recitals above are hereby incorporated as if fully set forth herein.

<u>Section 2</u>: The total number of ballots cast at the special recall election, as shown by the Certification of Election Returns, was 18,469.

<u>Section 3</u>: As shown by the County Election Certification, the number of votes cast for the candidates for District Two Councilmember in the special recall election was as follows:

Section 4: That it is hereby found, determined and declared of record that the election results shown in the Certification of Election Returns and set forth in this Resolution are officially declared, adopted, and canvassed and the following candidate did receive a majority of all votes cast in the special recall election, and is hereby issued a Certificate of Election, with a term of office commencing immediately and ending in January 2029 when a successor is elected and qualified:


