Dear Mesa Planning & Zoning Board,

RE: Rezone Request for Parcels 13854038, 13854043, 13854036 from T4-NF to T5-MS

OZ Development (Developer) represents the land owner OZ16 QOZB, LLC (Owner). Owner purchased property at the Southwest Corner of Country Club Drive & Main Street to put together an assemblage of 7 parcels for a proposed Multi-Family / Mixed use project. It is the intent of the Developer to consolidate these parcels together to make a unified project. The Developer also intends to "opt-in" to the Form Based Code (FBC) which has an overlaying "Transect Zone" which apply to this property. Of the 7 parcels, the 4 parcels in closest proximity to Main Street and Country Club Drive are zoned T5-MS and the contiguous other 3 parcels are zoned T4-NF. (See attached Map) To apply consistent design standards under the FBC, it is the request of the Developer to rezone the FBC Overlay of Parcels 13854038, 13854036, and 13854043 from T4-NF to T5-MS.

The Mesa 2040 General Plan character designation for the site is Downtown and specifically identified as being within a Station Area in the Main Street/Country Club Transit Corridor. The focus of the Downtown character type is to create a pedestrian friendly, transit rich environment that is alive with options for housing, employment, shopping, entertainment and events. Our proposed project complies with the General Plan as we are designing Buildings of varying heights between 5-8 stories, fronting buildings to Main & Country Club Drive with highly transparent retail space along Main Street. Parking is integrated into the structure using podium parking, and will be set back off Main Street a minimum of 50'. We are planning for 400 units of living space, which will be directly across from the transit station @ Main / Country Club and will engage the pedestrian with excellent access to the street and light rail.


This property is also located within the Downtown-Urban Gateway development planning area within the Central Main Street Sub-Area Plan. The goal for the Downtown area is to take advantage of the light rail to create a highly urban environment that visitors identify as the heart of Mesa. The Downtown-Urban Gateway area is envisioned to develop in a manner that announces entrance into the Downtown. We meet the goals and vision of the Downtown-Urban Gateway by planning for 400 units of living space, which will be directly across from the transit station @ Main / Country Club and will engage the pedestrian with excellent access to the street and light rail. We feel our project will be a perfect entrance to Downtown Mesa being on the corner of Main Street and Country Club Drive with high density, planned pedestrian corridors, and new retail space that will front

Main Street. Currently the uses on this property are old and tired, underutilized, and are desperately in need of redevelopment that will provide an active urban environment.

As mentioned above, the subject property is part of 7 parcels that we would like to all be zoned T5-MS as part of the FBC Overlay. Our future development plans comply with the T5-MS Transect by integrating a mix of Retail along Main Street with 400 plus units of housing above to help support the light rail transit and engage pedestrians to the street. Our proposal has buildings fronting streets with no setbacks, between 5-8 stories bringing mid-rise project into an area that is the gateway into Mesa.

We would respectfully ask you to consider our proposal for rezone of the three parcels indicated from T4-NF to T5-MS. This will allow us to move forward with our proposed project in a unified zone building what we believe will be a great addition to the City of Mesa.
