RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, ABANDONING THROUGH EXTINGUISHMENT A 50-FOOT LANDSCAPE EASEMENT AND A 25-FOOT SIDEWALK EASEMENT LOCATED AT 6147 EAST MAIN STREET

WHEREAS, pursuant to Arizona Revised Statutes Title 28 §§ 7201-7215 and/or Mesa City Code Title 9, Chapter 10, the City Council has the authority to abandon, vacate or extinguish (collectively, hereafter, "abandon") unnecessary roadway, right-of-way, or easements to which the City holds right or title to. Additionally, the City generally has the right to release restrictive covenants it holds on real property.

WHEREAS, the City Council has determined that a 50-foot landscape easement and a 25foot sidewalk easement recorded on Lot 2 of the Final Plat of Broadview Center, recorded in Book 272 of Maps, Page 26, records of Maricopa County, Arizona, located at 6147 East Main Street, as hereafter described in **Exhibit A** and depicted in **Exhibit B**, are no longer needed.

WHEREAS Mesa City Code 9-10-2 permits the City Council to extinguish easements no longer needed by the City upon application and payment of the application fee.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

<u>Section 1</u>: All rights of the City of Mesa in and to the following 50-foot Landscape Easement and 25-foot Sidewalk Easement are abandoned and deemed extinguished:

THENCE SOUTH 00 DEGREES 18 MINUTES 36 SECONDS EAST, A DISTANCE OF 100.00 FEET TO A POINT COINCIDENT WITH THE NORTHEAST CORNER OF LOT 2 OF A FINAL PLAT KNOWN AS "BROADVIEW CENTER" ON FILE IN THE OFFICE OF THE MARICOPA COUNTY ARIZONA RECORDER IN BOOK 272, PAGE 26, SAID POINT BEING THE POINT OF BEGINNING;

THENCE CONTINUE SOUTHERLY ALONG THE EAST LINE OF SAID LOT 2, A DISTANCE OF 25.00 FEET;

THENCE DEPARTING SAID LINE, SOUTH 89 DEGREES 09 MINUTES 42 SECONDS WEST, A DISTANCE OF 598.82 FEET TO THE WEST LINE OF SAID LOT 2;

THENCE ALONG THE WEST LINE OF SAID LOT 2, NORTH 00 DEGREES 14 MINUTES 57 SECONDS WEST, A DISTANCE OF 25.00 FEET TO THE NORTHWEST CORNER OF SAID LOT 2;

THENCE ALONG THE NORTH LINE OF SAID LOT 2, NORTH 89 DEGREES 09 MINUTES 42 SECONDS EAST, A DISTANCE OF 598.79 FEET TO THE POINT OF BEGINNING.


