**Subject:** Use of a Cooperative Contract for the Purchase of One (1) 5-Yard Mini Concrete Mixer Body Truck (Addition) for the Transportation Department  
**(Funded by Local Streets Sales Tax) (Citywide)**

## Purpose and Recommendation

Council is requested to approve the award as recommended.

The Fleet Services and Transportation Department and Procurement Services recommend authorizing the purchase using the State of Arizona cooperative contract with Freightliner of Arizona, LLC. at \$210,000.00 based on estimated requirements.

## Background / Discussion

The Freightliner M2106 5-Yard Mini Concrete Mixer Truck is an essential component for the Transportation Concrete Repair work group. This equipment will allow staff to pick up concrete material directly from the manufacturer. The ability to directly pick up material aligns with the department's goal to improve response times for repair requests, reduce potential hazards, and an overall enhancement of public satisfaction.

The State of Arizona's cooperative contract has been competitively bid and meets the City's procurement requirements. Utilizing the State of Arizona's contract allows the City to receive competitive rates based on a formally solicited agreement. Freightliner has confirmed that discounted pricing is identical on both the State of Arizona's contract and the Maricopa County cooperative contract. The City believes the price is fair and reasonable and soliciting for this product would not result in the City receiving more favorable pricing or terms.
