6. Hear and discuss a presentation from 2025-2027 HRAB Strategic Plan.

Ms. Andrea Alicoate, Assistant to the City Manager, shared with the Board a summary of the Strategic Planning Meeting session in March 2025. She facilitated feedback and discussions from the Board regarding its updated mission and vision. She also summarized the Board's discussion about the future goals it would like to prioritize within the 2025-2027 HRAB Strategic Plan and in its action. She also advised the Board on the importance of key measurements applicable to the Board's upcoming priorities. She advised that continuing discussions about the Board's priority and measurements is necessary in tracking the Board's impact within the community. Ms. Alicoate answered questions and responded to feedback provided by the Board.

7. Hear a presentation and discuss the opportunity for residential input on the proposed 2025 - 2026 City budget.

Ms. Alicoate presented to the Board an overview of the ongoing 2025-2026 City Budget discussions. She guided the Board where it can find the data and information regarding the City Budget. She advised that there would be two community meetings open to the public in May and encouraged members to attend. Ms. Alicoate answered logistical questions about the meetings posed by the Board.
