Purpose and Recommendation

The purpose of this report is to request the approval of a Resolution authorizing the City Manager to enter into a Project Agreement (PA) between the Maricopa Association of Governments (MAG) and the City of Mesa.

The PA is for the Power Road: East Maricopa Floodway to Santan Freeway/Loop 202 Project (CP0104) Arterial Life Cycle Program (ALCP) project (RTP Project # ACI-PWR-20-03-A) which defines the regional reimbursement schedule for the Project.

Refer to Exhibit "A" for the location map of the project.

Staff recommend that Council approve this Resolution, authorizing Staff to seek ALCP reimbursements.

Background

In November 2004, the voters of Maricopa County approved a transaction excise tax for the purpose of implementing the Regional Transportation Plan (RTP). The arterial street component of the RTP, defined in the ALCP, includes major arterial streets and intersection improvements (Arterial Street Improvements) with a revenue allocation. The Federal Highway Administration (FHWA) allocated Surface Transportation Block Grant Program (STBG) and Congestion Mitigation and Air Quality (CMAQ) funds to the MAG region as sources of revenue. These are administered by the Arizona Department of Transportation (ADOT) and are eligible to be used to implement the RTP.

Discussion

Funds for ALCP are administered by the ADOT through its Regional Arterial Road

Fund (RARF) sub-account for arterial streets, and through allocations of the Federal Highway Administration's STBG and CMAQ funds that are allocated to the MAG region and administered by ADOT. Funds will be disbursed by ADOT once federal, state or local requirements are satisfied (as applicable), and upon the presentation of an invoice approved or reviewed with concurrence by MAG as provided in this Agreement.

The ALCP includes the following:

Design and construct a consistent six-lane arterial roadway within the limits of the project, including, bike lanes, a raised landscape median, dual left-turn lanes at major intersections, street lighting, vertical curb, gutter and sidewalk. All ADA facilities will be upgraded to current compliance. Traffic signals will be upgraded to City of Mesa standards. Storm drain facilities will also be upgraded as needed.

This Project is described in greater detail in the Project Overview submitted by the City, dated October 29, 2024 and on file in the offices of the City and MAG.

Alternatives

The City Council could choose not to enter into this Project Agreement with MAG. The City's lack of participation would prevent the City from receiving eligible ALCP reimbursement.

Fiscal Impact

The Power Road: East Maricopa Floodway to Santan Freeway/Loop 202 Project (CP0104) is an ALCP project and Mesa is eligible for reimbursement for 70% of the project total design cost or up to \$1,607,196.57, whichever is less. If the PA is not approved, then Mesa is no longer eligible for these. The total project design cost is estimated at \$2,295,995.10 and Mesa must upfront the money as the ALCP is a reimbursement program.

A breakdown of the total estimated construction cost for the Project is as follows:
