**Subject:** Three-Year Term Contract for Fence, Gate and Safety Rail Repair/Installation

for the Transportation (Citywide)

## **Purpose and Recommendation**

Council is requested to approve the Term Contract for Fence, Gate and Safety Rail Repair/Installation as recommended.

Transportation and Purchasing recommend awarding the contract to the lowest priced, responsive and responsible bidders, Biddle & Brown Fence Co. LLC (Primary) and Empire Fence LLC (Secondary) (a Mesa business) at \$500,000; annually, based on estimated requirements.

# **Background / Discussion**

This contract will provide for the repairs/installation of fencing, trash racks, safety rails and bollards. Work will be performed at a variety of locations within the City limits including but are not limited to, City-owned property, privately owned property, and commercial property for which permission to enter has been obtained and property owned by other government agencies. The contractor will be responsible for compliance with all federal, state and local laws, regulations, statutes, codes, permits, etc.

Per bid specifications, it is the City's intent to award a primary and secondary contractor. The primary contractor will provide services until the City determines it is in the best interests of the City to use the services of the secondary contractor.

#### **Alternatives**

Council may choose not to authorize the purchase and new responses will be solicited.

### **Fiscal Impact**

The total amount of \$500,000 is available in the Transportation operating budget through Local Streets Sales Tax funding.
