Subject: Three-Year Term Contract with Two-Year Renewal Options for Trailer Parts,

Automotive Lighting, Mirrors, and Safety Supplies for the Fleet Services

Department (Citywide)

Recommendation

Council is requested to approve the award as recommended.

The Fleet Services Department and Procurement Services recommend awarding the contract to the lowest, responsive, and responsible bidders, FleetPride, Inc. (a Mesa business); J.B. Poindexter & Co., Inc. dba Reading Truck Equipment, LLC.; Parts Authority Arizona, LLC.; Parts West Heavy Duty, LLC. dba Light House of Arizona; and Polygon Investment Group, Inc. dba Spectrac Suspension Center at \$255,000 annually with an annual increase allowance of up to 5% or the adjusted Producer Price Index.

Background / Discussion

This contract will be used to purchase Trailer Parts, Automotive and Truck Lighting Parts, Mirrors, and Safety Supplies required for various pieces of rolling stock equipment owned by the City of Mesa. The City's Fleet Department performs repairs on-site and requires a variety of these parts to keep City vehicles and equipment in good working condition.
