#### **Purpose and Recommendation**

The purpose of this report is to recommend modifications to the Falcon Field Airport's Schedule of Fees and Charges. If approved by City Council, the fees will go into effect on August 1, 2024.

#### **Background and Discussion**

Falcon Field Airport continues to serve the general aviation needs of the region. It currently rents City of Mesa-owned properties and facilities, including 361 regular T-hangars, 115 covered tie downs, 282 tie downs, 80 small end of hangar storage units and 8 large end of hangar storage units.

There are four major factors considered in determining the need to modify fees and charges. The factors include inflation, increasing demand for aircraft storage, comparable markets, and the Federal Aviation Administration (FAA). Administrative Maintenance and Operations costs are increasing substantially across the region due to inflation. These increases are identified particularly in the cost of energy and utilities, building and pavement materials and supplies, and interruptions in the supply chain. The second factor evaluated is the demand for aircraft storage. Demand for City-owned rental properties at Falcon Field has been steadily increasing, driving rents higher. For example, demand for City-owned rental properties at Falcon Field Airport has grown substantially. Falcon Field Airport has a Regular T Hangar wait list of almost six years; the Large T Hangar wait list exceeds 10 years; the Covered Tie Down wait list is over 2<sup>1</sup>/<sub>2</sub> years; and the Open Tie Down wait list is 13 months. The third factor, the comparable market, shows that similar Arizona General Aviation Airports are increasing their fees and charges. They are raising rates because of the rising costs of doing business. Finally, the FAA requires that Falcon Field Airport maximize its efforts to remain self-sustaining in order to continue to receive Federal Grants as a grant assurance.

Collectively, these factors have created the need to increase fees and charges at Falcon Field Airport. Falcon Field is proposing to increase the fees for Covered Tie Downs, Regular T-Hangars, Storage Room Rents, Wait Lists, Security Deposits, Fuel Flowage Fee for 100LL AVGAS and Alternative Fuel. Staff also proposes creating a separate Storage Room Cleaning Fee Deposit for Small Storage Rooms, similar to the existing fee that will be applicable to the Large Storage Rooms. These changes will enable the Airport to stay competitive with the rates being charged for facilities and services by similar businesses and airports and to continue to be self-sustaining.

Falcon Field Airport also proposes increases to a Special Events Parking on airport fee and a Special Events Administration fee. Other general aviation airports do not offer parking space for special events. At Falcon Field, parking spaces are prioritized for tenants.

### Methodology

Falcon Field Airport reviews its Schedule of Fees and Charges on an annual basis to determine the relevance and reasonableness of all fees and charges. The survey was conducted to compare similar fees and charges with surrounding general aviation airports. Fees are closely aligned with the Chandler Municipal Airport. We are comparable in type of facilities, services, and administration. Based on an analysis of the most recent survey results, Falcon Field proposes increases in Fees and Charges as outlined. The proposed fees provide additional financial resources for increased costs in utilities, insurance and pavement costs at the Airport and enable the Airport to stay more current with the rates being charged for enclosed aircraft storage.

### Alternatives

The alternative would be to leave the current fees in place and not reflect any adjustments.

#### **Fiscal Impact**

The estimated annual fiscal impact of these proposed fee adjustments is \$192,076.

#### **Coordinated With**

Falcon Field Airport has coordinated with the Office of Management and Budget on this recommendation to make changes to the Airport's Schedule of Fees and Charges.
