Subject: Purchase of Two Replacement/Upgrade Electronic Message Displays for the Mesa Arts Center as requested by the Arts and Culture Department
(Approximately \$84,000 funded the Mesa Arts and Entertainment Alliance and the remaining balance by the Mesa Arts Center Restoration Fund) (Sole Source) (Citywide)

Recommendation

Council is requested to approve the award as recommended.

The Arts and Culture Department and Purchasing recommend authorizing the purchase using the City of Peoria cooperative contract with YESCO LLC at \$130,733.35.

Background / Discussion

The electronic message displays for Mesa Arts Center's two monument signs along Main Street require replacement. The existing LED displays that were installed in early 2009 have reached end of life in terms of maximum output. LED technology that illuminates 24/7 has product degradation over time. The 20mm technology available 10 years ago was state of the art at the time. Since then, newer and more effective products exist that provide better resolution, enhanced appearance and greater energy efficiencies. Additionally, the manufacturer is currently limited in product parts replacement and there is no guarantee of continued parts availability; obsolescence is inevitable for the current electronic message displays. Upgrading to this new technology will include a five-year warranty which will remove the cost of the existing service agreement, equating to \$28,620 in maintenance savings.

The Mesa Arts Center signs and Prismview electronics were purchased in 2009 through YESCO using a Maricopa County cooperative contract. Since then YESCO has sold its LED business to Samsung Electronics. YESCO is the marketing arm for Samsung and Prismview electronics. These products and services can only be purchased from YESCO.
