5 **Take action on the following contracts:*****5-a** **22-1029** Purchase of a Print Shop Cutter (Replacement) for the Business Services Department **(Citywide)**

This purchase will provide a paper cutter to replace the Print Shop's paper cutter, which is broken beyond repair. It will be used to cut printed paper projects including direct mail, flyers and postcards, marketing collateral, and large volume cut jobs, for the City's Print Shop's internal customers/citywide departments.

The Business Services Department and Purchasing recommend awarding the contract to the lowest, responsive, and responsible bidder, Konica Minolta Business Solutions U.S.A. Inc., at \$37,500.

- *5-b** **22-1058** Reaward of the Purchase of Stage Curtains (Replacements) for the Mesa Arts Center, Ikeda and Piper Theaters, as requested by the Arts and Culture Department **(Citywide)**

Council approved the award to the lowest, responsive, and responsible bidder, IWEISS Holdings, LLC, dba IWEISS on June 20, 2022. However, upon award, IWEISS was unable to meet the required specifications as submitted in their bid response, specifically the brand of curtain specified. The City terminated the contract with IWEISS. The award is being recommended to the next lowest, responsive, and responsible bidder.

The Arts and Culture Department and Purchasing recommend re-awarding the contract to the second lowest, responsive and responsible bidder, Rose Brand Wipers, Inc., dba Rose Brand at \$65,472.

- *5-c** **22-1047** Purchase of Ellipsoidal Lighting Fixtures (Replacement/Upgrade) for the Arts and Culture Department **(Citywide)**

This contract will provide ETC Source Four LED stage lighting. The purchase is for the replacement of sixty-one fixtures, LED versions that are capable of line-level dimming. The lighting fixtures that are being replaced are original to the Mesa Arts Center building, built in 2005. This upgrade is part of the Mesa Arts Center's effort to become more environmentally friendly, while improving the lighting in the various areas where the lighting fixtures are located.

The Arts and Culture Department and Purchasing recommend awarding the contract to the lowest, responsive, and responsible bidder, Clearwing Systems Integration, LLC, at \$70,000.

- *5-d** **22-1037** Ratification of the Emergency Purchase for Custodial Services for Parks and Sports Fields Facilities for the Parks, Recreation and Community Facilities Department **(Citywide)**

This emergency purchase provides custodial cleaning services to maintain sanitization and overall cleanliness for three months of services from August 1, 2022 through October 31, 2022. The emergency purchase is due to the current contractor, Carnation Building Services, Inc., closing their business on July 31, 2022. The City is in the process of re-bidding this contract with an anticipated Council award by November 1, 2022.

The Parks, Recreation and Community Facilities Department and Purchasing recommend ratifying the purchase from the contract with Plan B Facility Services, at \$128,037, based on estimated requirements.

5-e [22-1055](#) Dollar-Limit Increase to the Term Contract for Painting Services for the Parks, Recreation and Community Facilities Department **(Citywide)*

This contract provides non-exclusive, pre-qualified painting contractors list to perform painting services for various City facilities/projects on an as-needed basis. The City is currently in Year 5 of the contract. PRCF currently has high-cost projects planned that have been added since the contract was renewed, including the Mesa Arts Center exterior repaint and Falcon Field water tower coating repairs.

The Parks, Recreation and Community Facilities Department and Purchasing recommend increasing the dollar-limit with Ghaster Painting & Coatings, Inc.; Skyline Builders & Restoration, Inc.; A & H Painting Inc.; and First Choice Restoration Inc., year 5 by \$750,000, from \$535,000 to \$1,285,000 annually, based on estimated usage.

5-f [22-1031](#) Dollar-Limit Increase for the Use of Cooperative Contracts for PC Cycle Replacement and Supplemental Computers, Ruggedized Laptops and Tablets for various City Departments as requested by the Department of Innovation and Technology **(Citywide)*

This contract provides for the City's PC Cycle Replacement program and provides supplemental purchases of computer equipment. Supplemental purchases are made for customer departments to meet their current and future technology needs both known and unknown. Staff was able to renew the contract at the last amount approved by Council, but was not able to increase the contract administratively to accommodate the anticipated purchases.

The Department of Innovation and Technology and Purchasing recommend increasing the dollar-limit using the State of Arizona cooperative contracts with Dell Marketing LP; Apple Computer, Inc.; Panasonic Solutions; and Microsoft Corporation by \$80,000; from \$2,440,000 to \$2,520,000, based on projected usage for scheduled device replacement, and for supplemental purchases for new needs by departments.

5-g [22-1048](#) One-Year Term Contract for Validated Solid Phase Extraction Columns for Drug Analysis for the Mesa Police Department (Sole Source) **(Citywide)*

This contract will provide for the purchase of validated solid phase extraction columns from Tecan Corporation. These columns are used to extract blood samples for drugs such as THC, methamphetamine, cocaine and Narcotic analgesics. Tecan columns were evaluated in a laboratory validation process and were chosen based on their performance and cost.

The Police Department and Purchasing recommend awarding the contract to the sole source vendor, Tecan SP, Inc., at \$50,000 annually, based on estimated usage.

5-h [22-1053](#) One-Year Term Contract for the Maintenance of Compressors, Generators and Dryers for the Mesa Police Department (Sole Source) **(Citywide)*

This contract will provide maintenance for the dryers and compressors, which are critical pieces of equipment used by Forensic Services to process evidence.

The Police Department and Purchasing recommend awarding the contract to the sole source vendor, Atlas Copco, at \$35,500 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

5-i [22-1056](#) Purchase of DNA Mixture Interpretation Software and Maintenance (Replacement/Upgrade) for the Mesa Police Department (Sole Source) **(Citywide)*

In April 2019, Council approved the purchase of DNA Mixture Interpretation Software for the Police Department's Forensic Services Division. The software program assists in identifying suspects and aids in solving crimes. Software is available to provide a continuous model of interpretation. Forensic Services already uses STRmix software and it is imperative to continue with the same. This purchase will provide four STRmix licenses, upgrade and maintenance, and validation.

The Police Department and Purchasing recommend awarding the contract to the sole source vendor, NicheVision Forensics, LLC, at \$108,500. This purchase is funded by Department of Justice, DNA Capacity Enhancement and Backlog Reduction Grant.

5-j [22-1064](#) Purchase for QIASymphony Instrument Validation for the Mesa Police Department (Sole Source) **(Citywide)*

In June 2020, Council approved the purchase of a QIAGEN QIASymphony SP instrument, an automated extraction system that has the capability of extracting up to 96 samples at the same time. Forensic Services is now requesting validation of this instrument. Validation is required before the instrument can be used on DNA casework.

The Police Department and Purchasing recommend awarding the contract to the sole source vendor, QIAGEN, at \$58,870. This purchase is funded by Department of Justice, DNA Capacity Enhancement and Backlog Reduction Grant.

5-k [22-1057](#) Purchase of EIPro Software Solution for the Mesa Police Department (Sole Source) **(Citywide)*

In 2009, Council approved the purchase of IAPro, a database software from CI Technologies, Inc., used by the Police Department's Professional Standards Division, to investigate, document, track, and analyze data obtained through investigations and community contacts. The software provides an efficient means to track sworn and civilian staff behavior and incidents. The capabilities of IAPro include EIPro, an advanced early intervention tool, that can provide supervisory and command staff critical information regarding employee behavior in real-time.

The Police Department and Purchasing recommend awarding the contract to the sole source vendor, CI Technologies, Inc., at \$28,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index. This purchase is funded by Public Safety Sales Tax.

5-l [22-1035](#) Ratification of the Emergency Purchase for Refuse Truck Repairs for the Environmental and Sustainability Department (as requested by the Fleet Services Department) **(Citywide)*

In May, one of the Solid Waste front loader refuse trucks caught fire and needed to be repaired to get the vehicle back into operation. Due to the damage from the fire and the nature of repairs required for the refuse truck, Fleet Services had to send this vehicle to AMREPS's local sole source dealer, Wastequip WRX, to complete the repairs.

The Environmental and Sustainability and Fleet Services Departments and Purchasing recommend ratifying the purchase from the contract with AMREP Manufacturing Company, LLC, at \$33,443.90.

***5-m [22-1051](#) Extension and Dollar-Limit Increase to the Term Contract for Light-Duty Automotive Body Repair Services for the Fleet Services Department (Citywide)**

This contract provides a qualified vendor list of automotive body repair firms to provide non-exclusive repair service, on an as-needed basis. The City rebid this contract in June, and resolicited to potentially get additional vendors. The contract extension is needed to complete the resolicitation process/contract award, and the dollar-limit increase is needed for Fleet Services until the new contract is awarded, which is anticipated to be effective November 1, 2022.

The Fleet Services Department and Purchasing recommend extending the contract through October 31, 2022, and increasing the dollar-limit with Caliber Bodyworks of Arizona, Inc., dba Caliber Collision Mesa-East Main St.; East Valley Collision LLC; LP's Body & Paint Center LLC; and 2nd GEN LLC, dba Maaco Collision Repair & Auto Painting (all Mesa businesses), year 5 by \$160,000, from \$660,000 to \$820,000.

***5-n [22-1033](#) Three-Year Term Contract with Two Years of Renewal Options for CPVC and PVC Fittings, Pipe, Valves, and Parts for the Water Resources Department (Citywide)**

This contract is essential for the purchase of CPVC and PVC fittings, pipe, valves, and related parts and materials used in the maintenance for the City's three water reclamation plants, two water treatment plants, multiple pump stations, well sites, and lift stations.

An evaluation committee recommends awarding the contract to the qualified proposals from Harrington Industrial Plastics, Ryan Herco Flow Solutions, and McMaster-Carr Supply Company, at \$800,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

***5-o [22-1032](#) Purchase of Cloth Media Filters (Replacement) for the Water Resources Department (Sole Source) (Citywide)**

This purchase will provide Aqua Diamond Cloth Media Filters used for wastewater treatment at the Northwest Water Reclamation Plant.

The Water Resources Department and Purchasing recommend awarding the contract to the sole source vendor, Aqua-Aerobic Systems, Inc., at \$125,000.

- *5-p** **22-1050** Use of Cooperative Contracts for Term Contracts with renewal options for Science and Lab Supplies and Equipment for the Water Resources Department **(Citywide)**

This contract provides laboratory consumables, supplies, and equipment for the Water Resources Compliance Laboratory and the water treatment and wastewater treatment plants. Due to current issues with long lead times in obtaining laboratory supplies, City staff determined awarding multiple vendors to this contract would be beneficial. The goal is to improve the availability of needed products at the best possible pricing.

The Water Resources Department and Purchasing recommend authorizing the purchase using cooperative contracts: OMNIA Partners with Fisher Scientific; NCPA with McKesson Medical-Surgical Government Solutions; Sourcewell with Carolina Biological; and State of Arizona with VWR International, LLC, at \$200,000 annually, based on estimated usage.

- *5-q** **22-1059** Three-Year Term Contract with Two Years of Renewal Options for Recycling and Disposal of Cathode Ray Tube (CRT) Devices for the Environmental Management and Sustainability Department (Single Response) **(Citywide)**

This contract will provide a Contractor to responsibly recycle CRT display devices collected at the City's Household Hazardous Materials Facility. The Contractor is responsible for packaging, transportation, recycling, disposal, and receipt, of the CRT devices of varying sizes and conditions each week.

The Environmental Management and Sustainability Department and Purchasing recommend awarding the contract to the single, responsive, and responsible bidder, eGreen IT Solutions, LLC, at \$100,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

- *5-r** **22-1062** Use of a Cooperative Contract for a Four-Year and Two-Month Term Contract for Trash, Recycle, and Compost Barrel Lids for the Environmental Management and Sustainability Department **(Citywide)**

This contract will provide black, green, and blue 95-gallon barrel lids. The City currently does not have a contract with Rehrig for replacement barrels. Lids are the most replaced part of a barrel, at a lesser cost and more environmentally friendly than replacing the entire barrel.

The Environmental Management and Sustainability Department and Purchasing recommend authorizing the purchase using the Omnia Partners cooperative contract with Rehrig Pacific Company, at \$150,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

- *5-s** **22-1049** One-Year Term Contract with Four Years of Renewal Options for Residential Gas Meters, 400 Class for the Materials and Supply Warehouse (for the Energy Resources Department) (Single Response) **(Citywide)**

This contract will provide residential gas meters, 400 class, used for monitoring the volume of customer gas usage, and for billing of services. These meters are used for new service installations and repair work by Energy Resources - Gas Utility. Materials and Supply place orders and maintains stock inventory as needed.

The Business Services and Energy Resources Departments and Purchasing recommend awarding the contract to the single, responsive, and responsible bidder, Tri-Pacific Supply, Inc., at \$104,000 annually, with an annual increase allowance of up to 5%, or the adjusted Producer Price Index.

- *5-t** **22-1052** One-Year Term Contract with Four Years of Renewal Options for Magnesium Anodes for the Materials and Supply Warehouse (for the Energy Resources Department) **(Citywide)**

This contract will provide 1 and 32 pound magnesium anodes for use in the City's natural gas distribution system. Anodes protect against galvanic corrosion of steel pipe. These anodes will be used by Gas Utility for new construction projects and the maintenance and repair of existing utilities.

The Business Services and Energy Resources Departments and Purchasing recommend awarding the contract to the lowest, responsive, and responsible bidder, International Corrosion Control, Inc., at \$116,000 annually, with an annual increase allowance of up to 5%, or the adjusted Producer Price Index.

- *5-u** **22-1060** One-Year Term Contract with Four Years of Renewal Options for Rotary Gas Meters for the Materials and Supply Warehouse (for the Energy Resource Department) **(Citywide)**

This contract will provide large capacity gas meters used in the City's natural gas distribution systems for the purpose of billing customer gas usage. These meters are for new construction projects and maintenance and repair of existing utilities. Materials and Supply place orders and maintains stock inventory as needed.

The Business Services Department and Purchasing recommend awarding the contract to the lowest, responsive, and responsible bidder, Natural Gas Solutions North America, LLC, at \$531,000 annually, with an annual increase allowance of up to 5%, or the adjusted Producer Price Index.

5-v [22-1054](#) Purchase of Natural Gas Leak Survey Equipment (Replacement/Upgrade) for the Energy Resources Department **(Citywide)*

This purchase will provide equipment for natural gas leak surveys and natural gas odorant testing for the Energy Resources Department. The department is responsible for leak surveying the City's natural gas system to meet federal code, Arizona Corporation Commission, and Pipeline and Hazardous Materials Safety Administration (PHMSA) compliance. This equipment will upgrade its current system to meet industry standards and utilize the latest technology in gas leak detection.

The Energy Resources and Purchasing recommend awarding the contract to the lowest, responsive, and responsible bidder, Heath Consultants Incorporated, at \$98,000.

5-w [22-1030](#) Use of a Cooperative Contract for a Three-Month Term Contract with Four Years of Renewal Options and Dollar-Limit Increase for 3M ReflectORIZED Sign Sheeting for the Transportation Department **(Citywide)*

The Department uses reflectORIZED sign sheeting to fabricate traffic control signs maintained throughout the City for public safety. The dollar limit increase is required due to annual usage and vendor pricing increases.

The Transportation Department and Purchasing recommend authorizing the purchase using the State of Arizona cooperative contract; and increasing the dollar-limit with 3M Company, by \$15,000, from \$25,000 to \$40,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

5-x [22-1061](#) One-Year Term Contract with Four Years of Renewal Options for LED Traffic Signal Heads, Mounts, Push Buttons, and Hardware for the Materials and Supply Warehouse (for the Transportation Department) **(Citywide)*

Transportation will use these LED traffic signal heads, mounts, push buttons, and hardware to maintain and modify existing traffic signals and as a supply for the construction of new traffic signals.

The Transportation Department and Purchasing recommend awarding the contract to the lowest, responsive, and responsible bidders: Advanced Traffic Products, Inc.; JTB Supply Company; and McCain, Inc., at \$365,000 annually, with an annual increase allowance of up to 5%, or the adjusted Producer Price Index.

- *5-y [22-1063](#)** One-Year Term Contract with Two, Two-Year Renewal Options for Wastewater Odor Control Chemical, Services, and Equipment for the Water Resources Department **(Citywide)**

The contract will provide the following odor-control products and services for the City's wastewater collection and treatment system: peroxide regenerated iron-sulfide control services at the Brooks Sulfide Control Station; odor control pilot testing services at various locations; and furnish and install chemical dosing equipment with an advanced web-based control system.

An evaluation committee recommends awarding the contract to the highest scored proposals from US Peroxide, LLC, dba USP Technologies; EWT Holdings III Corp., dba Evoqua Water Technologies, LLC; and Hill Brothers Chemical Company, at \$250,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

- *5-z [22-1010](#)** Brown Road Water Treatment Plant Network and Control System Upgrades - Construction Manager at Risk (CMAR), Guaranteed Maximum Price (GMP) No. 2 **(District 5)**

This project includes the remaining scope of work necessary to complete the needed upgrades to the existing communication network, control systems, and motor controls. Upgrades to the network and control systems are required to bring plant operation controls and monitoring up to current standards.

Staff recommends awarding the contract to Sturgeon Electric Company, Inc., in the amount of \$2,188,346.73, (GMP No. 2), and authorizing a change order allowance in the amount of \$218,834.67 (10%), for a total of \$2,407,181.40. This project is funded by Utility Systems Revenue Obligations.

6 Take action on the following resolutions:
