Subject: Three-Year Term Contract with Two Years of Renewal Options for

Emergency and Non-Emergency Response for Hazardous, Non-Hazardous, Universal and Biohazardous Wastes for the Environmental Management and

Sustainability Department (Citywide)

Recommendation

Council is requested to approve the award as recommended.

A committee representing the Environmental Management and Sustainability Department and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the qualified proposals from Advanced Chemical Transport, Inc. dba ACTenviro; Emergency Environmental Services, LLC (a Mesa business); Environmental Response, Inc.; GrayMar Environmental Services, Inc.; and Kary Environmental Services, Inc. at \$180,000 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

Background / Discussion

This contract will provide Emergency and Non-Emergency Response for Hazardous, Non-Hazardous, Universal and Biohazardous Wastes:

<u>Group A:</u> Non-Emergency (routine/scheduled) pickup and disposal of known/unknown hazardous, non-hazardous, and universal wastes for the City of Mesa;

<u>Group B:</u> Emergency and Non-Emergency response, site-cleanup, and disposal of biohazardous wastes only, for the City of Mesa; and

<u>Group C:</u> Emergency Response, site-cleanup, and disposal of known/unknown hazardous, non-hazardous, and universal wastes for the City of Mesa.

The City received six proposal responses of which all vendors met the minimum qualifications, and a No Bid response. The evaluation committee evaluated the six proposals and pricing analysis in accordance with the City's established policies and procedures. Reference checks were conducted for all offerors susceptible for award. One vendor was deemed as Non-Responsive. The committee completed scoring of the responses against the scoring criteria in the solicitation. Scoring of the pricing was completed using the pricing formula in the solicitation. Based on the evaluation results, award is being recommended to the susceptible for award respondents.
