THENCE leaving said right-of-way line, along said Public Utilities and Facilities Easement, North 89 degrees 16 minutes 38 seconds East a distance of 254.77 feet;

THENCE along said Public Utilities and Facilities Easement, North 07 degrees 43 minutes 50 seconds West a distance of 399.11 feet;

THENCE along said Public Utilities and Facilities Easement, North 82 degrees 16 minutes 10 seconds East a distance of 554.80 feet;
