RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA,  
MARICOPA COUNTY, ARIZONA, APPROVING THE MODIFIED  
ASSESSMENT RATES FOR THE MESA TOWN CENTER  
IMPROVEMENT DISTRICT NO. 228.

WHEREAS, the City Council of the City of Mesa is proposing to modify the assessment rates for the Mesa Town Center Improvement District No. 228 as established by Resolution No. 5617, modified on the 3<sup>rd</sup> day of April, 2000 by Resolution No. 7486.

WHEREAS, on the 16<sup>th</sup> day of May 2022, the City Council of the City of Mesa reviewed and approved the modified assessment rates for the Mesa Town Center Improvement District No. 228 as established by Resolution No. 5617, modified on the 3<sup>rd</sup> day of April 2000 by Resolution No. 7486, as stated in the attached in Exhibit A; and
