Subject: Purchase of One Mechanical Street Sweeper (Replacement) for the Transportation Department **(Funded by the Environmental Compliance Fee) (Citywide)**

Recommendation

Council is requested to approve the award as recommended.

The Fleet Services and Transportation Departments and Purchasing recommend authorizing the purchase using the State of Arizona cooperative contract with Freightliner of Arizona at \$345,196.83.

Background / Discussion

This purchase will provide one X-Broom mechanical sweeper for Transportation Field Operations. It will replace an existing sweeper that has reached the end of its useful life. The sweeper that is being replaced has met the established criteria for replacement that will be either traded, auctioned, sold, or deployed to special uses.

The new sweeper will complement the current sweeping schedule in accomplishing Transportation's residential street sweeping performance measure. The department has a goal of sweeping residential streets every four weeks, and to meet this goal, adequate staffing and equipment are necessary.

The State of Arizona contract allows the City to purchase Freightliner/Nescon X-Broom Sweeper deliverable within six to eight months. Also, the manufacturing order window has been shortened due to microchips and supply chain shortages. If the City competitively bids, it will take 16 to 24 months to manufacture the sweeper.
