A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, ABANDONING THROUGH EXTINGUISHMENT AN 8-FOOT PUBLIC UTILITY EASEMENT LOCATED AT 4611 EAST FAIRBROOK CIRCLE.

WHEREAS, pursuant to Arizona Revised Statutes Title 28 §§ 7201-7215 and/or Mesa City Code Title 9, Chapter 10, the City Council has the authority to abandon, vacate or extinguish (collectively, hereafter, "abandon") unnecessary roadway, right-of-way, or easements to which the City holds right or title to. Additionally, the City generally has the right to release restrictive covenants it holds on real property.

WHEREAS, the City Council has determined the 8-foot public utility easement recorded on Lot 104 of the Plat for Sundance Groves, recorded in Book 285 of Maps, Page 10, records of Maricopa County, Arizona, located at 4611 East Fairbrook Circle, as hereafter described in **Exhibit A** ("Public Utility Easement"), is no longer needed.

WHEREAS Mesa City Code 9-10-2 permits the City Council to extinguish easements no longer needed by the City upon application and payment of the application fee.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

<u>Section 1</u>: All rights of the City of Mesa in and to the 8-foot Public Utility Easement are abandoned and deemed extinguished:

LEGAL DESCRIPTION


Thence South 76 degrees 42 minutes 30 seconds West, a distance of 8.15 feet, along said South boundary line, to the **Point of Beginning**;
