Subject:	Purchase for Three Rotary Lifts and Three Mobile Equipment Lifts (All Replacements) for the Fleet Services Department (Citywide)

Purpose and Recommendation

Council is requested to approve the award as recommended.

The Fleet Services Department and Purchasing recommend authorizing the purchase using the Sourcewell cooperative contract with Rotary Lift at \$84,764.35; and the State of Arizona cooperative contract with Mohawk Resources, LTD at \$70,981.70.

Background / Discussion

This contract will provide for the purchase and installation of three (3) two post surface equipment lifts, removal of the current in-ground lifts for Fleet Services' West Shop, and the purchase and set-up of six (6) mobile equipment lifts for Fleet Services' East Shop.

The Sourcewell and the State of Arizona cooperative contracts have been competitively bid and meet the City's procurement requirements. Staff were unable to locate other cooperative contracts to compare and obtained quotes for these lifts from additional vendors to compare pricing. Fleet Services and Purchasing believe the pricing for the two post surface lifts and mobile lifts are fair and reasonable. It is in the City's best interest to purchase from the cooperative contracts.
