RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, DESIGNATING THE GENERAL ELECTION DATE AND PURPOSES OF THE GENERAL ELECTION; PROVIDING THE DEADLINE FOR FILING ARGUMENTS FOR AND AGAINST BALLOT MEASURES; PROVIDING THE DEADLINE FOR VOTER REGISTRATION; AND PROVIDING THE TIMES THAT POLLS WILL BE OPEN.

WHEREAS, pursuant to Resolution No. 11797, the City of Mesa called a Primary Election for August 2, 2022 to nominate candidates for Councilmembers in Districts 4, 5, and 6

WHEREAS, pursuant to Section 201(F) of the Mesa City Charter, a General Election shall be held if no candidate for a Council District seat receives a majority of all the valid ballots cast during the Primary Election for such seat.

WHEREAS, the City Council believes several issues of importance in the operation of the City of Mesa should be submitted to the voters for their approval.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mesa, Maricopa County, Arizona as follows:

<u>Section 1</u>. That November 8, 2022 has been set as the date for holding the General Election in the City of Mesa for the purpose of electing Councilmembers in Council Districts 4, 5, and 6 whose terms shall expire in January 2027, where no candidate was elected at the Primary Election.

Section 2. At the General Election, the qualified electors of the City shall also vote on the following measures:

Question 1Alternative Expenditure Limitation (Home Rule)Question 2General Obligation Bonds – Public SafetyProposition 476City Charter Section 205(D) – Meet and Confer ExceptionProposition 477City Charter Section 609 – Procurement

At the General Election, the qualified electors of the City may be asked to vote on any additional propositions or questions that legally qualify for the ballot.

<u>Section 3</u>. Arguments advocating or opposing ballot measures shall be filed with the Mesa City Clerk's Office, 20 East Main Street, Suite 150, not later than 6:00 p.m. on Wednesday, August 10, 2022. Arguments must include a sworn statement from the person(s) sponsoring the argument.

<u>Section 4</u>. To be qualified to vote, citizens must be registered by October 10, 2022 for the General Election. Maricopa County registration and voting lists will be used for municipal elections.

Section 5. Polling places shall open at 6:00 a.m. and close at 7:00 p.m. on Election Day.
