Neighborhood Meetings: In response to the COVID-19 pandemic, our neighborhood meeting was held virtually via Zoom.

Neighborhood meeting: May 3, 2022, 5:30- 6:30 pm. 11 attendees. Since the meeting was held virtually via Zoom, there is no sign in sheet.

Correspondence and Telephone calls:

1. Letter regarding the neighborhood meeting mailed to the contact list of neighbors within 1,000 feet and HOAs and registered neighborhoods within 1 mile (458 neighbors) on April 20, 2022 (see attached list and copy of the letter).
2. Neighborhood meeting was held on May 3, 2022.
3. Corresponded via email with several neighbors with questions regarding the project.
4. The second letter regarding the public meeting information was mailed to the contact list of neighbors within 1000 feet and HOAs and registered neighborhoods within 1 mile (458 neighbors) on May 24, 2022 (see attached list and copy of the letter).

Results: There were 458 persons on the contact list as the date of the Citizen Participation Report (see attached notification lists)

Community Outreach Summary

On May 3, 2022, we held a virtual neighborhood meeting. Neighbors that lived within 1,000 feet and registered neighborhood associations and HOAs within 1 mile were notified of this meeting. Approximately 11 neighbors attended this meeting.

At this meeting, we presented our proposed site plan and graphics of our intended architectural style.

The neighbors expressed concerns regarding property values, duration of construction, dust control, traffic patterns, ingress and egress, air handlers, hours of operation, height, and noise generation.

The responses to the concerns were answered during the neighborhood meeting. Cassandra Ayres expressed that in general property values rise when a site gets developed versus vacant land. She also stated that dust control is regulated by ADEQ, and the construction team will comply. She stated that there is a master traffic study for Eastmark that addresses traffic counts. She also stated that the main points of ingress and egress are on Signal Butte Road. She stated it is too early to discuss hours of operation as there are not end users at this time. She went on to address that the buildings are a maximum of 50 feet in height and any end user will need to comply with the City of Mesa Noise Ordinance.

Pre-Submittal Meeting: The pre-submittal meeting with the City of Mesa planning staff was held on January 6, 2022.

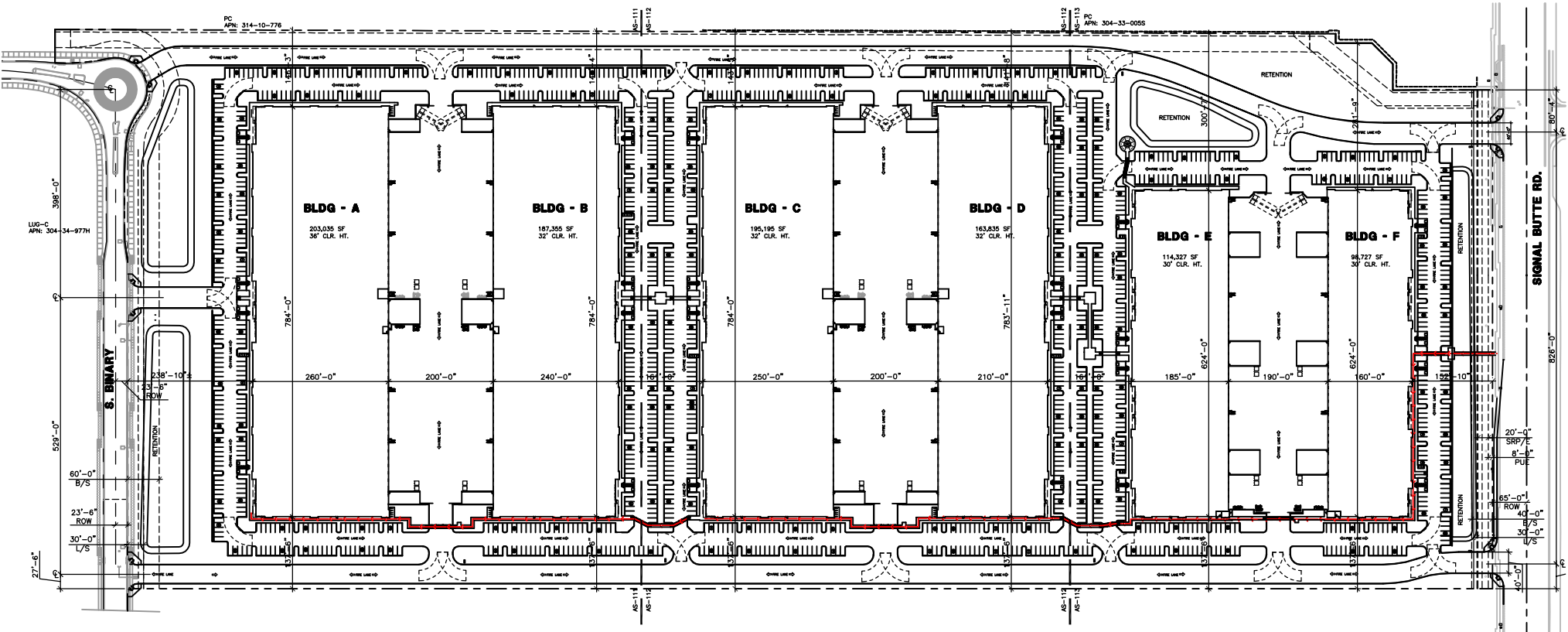
