

AUDIT, FINANCE & ENTERPRISE COMMITTEE ACTION MINUTES

March 24, 2022

The Audit, Finance & Enterprise Committee of the City of Mesa met in the lower-level meeting room of the Council Chambers, 57 East 1st Street, on March 24, 2022, at 8:50 a.m.

Chairperson Freeman conducted a roll call.

1. Items from citizens present.

There were no items from citizens present.

2-a. Hear a presentation, discuss, and provide a recommendation on the proposed fees and charges for the following City departments: Falcon Field, Development Services, and Economic Development.

Management and Budget Assistant Director Brian Ritschel introduced Operations Budget Coordinator Linda Jones, who displayed a PowerPoint presentation on the recommended fees and charges. (See Attachment 1)

Mr. Ritschel stated the Office of Management and Budget (OMB) collaborates annually with all City departments to review the fees, charges, and schedules for any necessary changes by conducting a market comparison to evaluate the cost of providing the services and the applicable fees. He noted the proposed effective date for these fees and charges will be July 1, 2022, and the fiscal impact of the recommendations are estimated at \$175,000 annually. Mr. Ritschel remarked Falcon Field, Development Services, and Economic Development are the departments recommending modifications. He identified the recommendations for Falcon Field. (See Pages 3 and 4 of Attachment 1)

In response to questions from Councilmember Luna regarding the open tie-down aircraft fee, Airport Director Corinne Nystrom explained the open tie-down fees are for aircraft that are tied down on the ramp and hundreds are leased out on a month-to-month basis. She mentioned due to the growth and development, there is currently a waitlist for open tie-downs. She reported fees were raised last year for the large hangars and approximately 3% the year prior. She discussed the wait times for other types of hangars.

She confirmed the increase for special event parking for non-aeronautical type events, adding if the event is for aeronautical or charitable purposes, then there was no charge.

In response to a question posed by Vice Mayor Duff regarding the difference between the waitlist deposit and waitlist fee, Ms. Nystrom explained the waitlist deposit refund is for the cover tie-downs and hangars. She clarified there is a nominal fee to cover administrative costs if someone changes their mind after holding a spot on the waiting list.

In response to a question from Chairperson Freeman, Mr. Ritschel commented the waitlist deposit refund fee is \$27.

Mr. Ritschel presented fees and charges comparable with other general aviation airports in the area. (See Pages 5 of Attachment 1)

Mr. Ritschel provided the recommendations for the Development Services Department. He stated by combining two processes, the fees will remain the same and the process will be more efficient and effective. He added minimal text changes regarding marijuana facilities are recommended as well. (See Page 6 of Attachment 1)

Mr. Ritschel discussed Downtown Transformation and Economic Development fee recommendations and explained the intention is to increase the monthly surface parking fees for open parking spots, and for shaded and unshaded garages. He commented on monthly covered parking rates for Chandler, Glendale, Phoenix, and Tempe, adding that Mesa's rates are considerably lower. (See Pages 7 and 8 of Attachment 1)

Responding to a question from Chairperson Freeman, Mr. Ritschel replied parking fees are reviewed for modifications by each department on an annual basis.

Mr. Ritschel outlined the next steps would be for Council to consider the amendments for proposed fees and charges on April 18, 2022, which would be effective July 1, 2022. (See Page 9 of Attachment 1)

Vice Mayor Duff suggested considering implementing metering on Main Street since downtown parking is becoming a problem. She mentioned metered parking would generate revenue for the Downtown Mesa Association.

It was moved by Committeemember Duff, seconded by Committeemember Luna, that the proposed fees and charges for Falcon Field, Development Services, and Economic Development be forwarded on to the full Council for discussion and consideration.

Upon tabulation of votes, it showed:

Carried unanimously.

<u>2-b.</u> Hear a presentation, discuss, and provide a recommendation on removing the Stormwater Drainage Impact Fee from the Mesa Development Impact Fees in Title 5, Chapter 17 of the Mesa City Code.

Management and Budget Assistant Director Brian Ritschel introduced Operations Budget Coordinator Linda Jones and displayed a PowerPoint presentation on the discontinuation of the storm water impact fee. (See Attachment 2)

Mr. Ritschel stated the City has collected sufficient revenue to pay off all the storm water project eligible debt. He explained Parks, Cultural, and Library impact fees have been discontinued and Police, Fire, Water, and Wastewater continue to have impact fees. He provided the next steps for Council. (See Pages 2 and 3 of Attachment 2)

In response to a question posed by Chairperson Freeman regarding the amount collected to pay off the debt, Mr. Ritschel estimated approximately \$600,000 to \$700,000 was collected annually. He mentioned due to the increase in development, the total collected the previous year ending June 30, 2021 was \$1.4 million.

It was moved by Committeemember Luna, seconded by Committeemember Duff, that the proposed recommendations for removing the Stormwater Drainage Impact Fee from the Mesa Development Impact Fees in Title 5, Chapter 17 of the Mesa City Code be forwarded on to the full Council for discussion and consideration.

Upon tabulation of votes, it showed:









Downtown Transformation (Economic Development Fee)






Downtown Transformation, cont. (Economic Development Fee)
