**Subject:** One-Year Term Contract with Two, Two-Year Renewal Options for Wastewater Odor Control Chemical, Services, and Equipment for the Water Resources Department **(Citywide)**

## Recommendation

Council is requested to approve the award as recommended.

A committee representing the Water Resources Department and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the highest scored proposals from US Peroxide, LLC dba USP Technologies; EWT Holdings III Corp. dba Evoqua Water Technologies, LLC; and Hill Brothers Chemical Company at \$250,000 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

## Background / Discussion

The contract will provide odor-control products and services for the City's wastewater collection and treatment system. The Request for Proposal solicited proposals for the following services and products:

- a. Peroxide Regenerated Iron-Sulfide Control (PRI-SC) services at the Brooks Sulfide Control Station.
- b. Provide odor control pilot testing services at various locations.
- c. Furnish and install chemical dosing equipment with an advanced web-based control system.

The City received three proposal responses which all met the minimum qualifications. The evaluation committee evaluated and scored the proposals relative to the scoring criteria in the solicitation (See Final Scoring). Based on the evaluation results, award is recommended to the highest scored, with multiple proposals for each Group.
