1. Chair's Call to Order.

Mr. Williams called the meeting to order at 6:00pm.

Mr. Holmes has served since July 2016, fulfilling two full terms. Mr. Williams stated that he was not able to attend tonight but we look forward to honoring him at a future meeting this fall.

(5c) Bill McAllister

Mr. McAllister has served since July 2019 and filled a full three-year term with the board and provided a valuable lens through his work and advocacy for people with disabilities. Mr. McAllister has been a partner with the City in other capacities such as programs and work conducted through the Community Development Block Grant.

6. Hear, discuss and approve the selection Chair and Vice-Chair positions for 2022-2023 Board year.

It was moved by Mr. McAllister and seconded by Ms. Faatoafe that Mr. Smith be nominated and selected to serve as the board Chair.
