

MESA HOUSING AUTHORITY GOVERNING BOARD RESOLUTION NO. ____

A RESOLUTION OF THE HOUSING SERVICES GOVERNING BOARD OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, APPROVING THE MESA PUBLIC HOUSING AUTHORITY INTERGOVERNMENTAL AGREEMENTS FOR THE HOUSING CHOICE VOUCHER VETERAN AFFAIRS SUPPORTIVE HOUSING PROGRAM BETWEEN THE CITY OF MESA HOUSING AUTHORITY AND THE TOWN OF GILBERT AND MARICOPA COUNTY OR THEIR RESPECTIVE PUBLIC HOUSING AUTHORITIES TO ALLOW VOUCHER PARTICIPANTS TO LEASE RENTAL UNITS IN THE TOWN OF GILBERT OR MARICOPA COUNTY ISLANDS.

WHEREAS, the Mesa Housing Authority ("MHA") administers the U.S. Department of Housing and Urban Development Housing Choice Voucher Veteran Affairs Supportive Housing ("VASH") program which combines voucher rental assistance for homeless veterans and their families with case management and clinical services provided by the Department of Veteran Affairs medical center and clinics;

WHEREAS, on occasion VASH program participants may desire to lease housing outside the jurisdiction of the MHA;

WHEREAS, the MHA believes it would be beneficial to the VASH program and VASH program participants to accommodate participant requests to lease outside the City of Mesa; and

WHEREAS, the following Arizona governmental entities have public housing authorities who wish to enter into individual intergovernmental agreements with the MHA to allow Mesa VASH program participants to lease housing in their respective jurisdictions: Town of Gilbert, and Maricopa County Islands.

NOW THEREFORE, BE IT RESOLVED BY THE HOUSING SERVICES GOVERNING BOARD OF THE CITY OF MESA, COUNTY OF MARICOPA, ARIZONA, AS FOLLOWS:

Section 1: Approving individual Intergovernmental Agreements for the Housing Choice Voucher Veteran Affairs Supportive Housing Program between the MHA and each of the following Arizona governmental entities or their respective public housing authorities: Town of Gilbert and Maricopa County.

Section 2: Authorizing and directing the Chairperson of the Mesa Housing Services Governing Board, or his designated representative, to sign the Intergovernmental Agreements with the Town of Gilbert and Maricopa County on behalf of the MHA and the City Clerk to attest to the signature thereon.
