**Subject:** Three-Year Term Contract with Two Years of Renewal Options for T-Shirts,

Artwork and Graphics for the Parks, Recreation and Community Facilities

(PRCF) Department (Citywide)

#### Recommendation

Council is requested to approve the award as recommended.

A committee representing the Parks, Recreation and Community Facilities Department and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the four, highest scored proposals from Billy E. Hancock Jr. dba F&B Graphics; Kimball Concepts, Ltd.; Vida Ventures, Inc. dba Rainbow Graffixx (all Mesa businesses); and Koehler Parker Inc. dba LogoWear Express at \$45,000 annually, based on estimated usage.

#### **Background / Discussion**

This contract will provide pre-qualified vendors to supply screened t-shirts, artwork and graphics for the PRCF Department. Approximately 20,000 t-shirts will be purchased throughout the year in varying quantities and colors with a variety of artwork styles. The shirts are furnished to support special events, program participants, volunteers, officials and administrative staff.

The City solicited Request for Proposals and received seven (7) proposal responses of which five (5) met the minimum qualifications and two were deemed as non-responsive. The evaluation committee evaluated and scored the five proposals relative to the scoring criteria in the solicitation. Based on the evaluation results, the committee recommends award to the four, highest scored proposals.
