A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA APPROVING AND AUTHORIZING THE CITY MANAGER TO ACCEPT PROPOSITION 202 FUNDS FROM THE SALT RIVER PIMA-MARICOPA INDIAN COMMUNITY AND ADMINISTER AWARDED FUNDS AS PASS-THROUGH GRANTS TO DESIGNATED AWARDEES.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA AS FOLLOWS:

Section 1: Arizona's Indian Gaming Compact provides that an Indian Tribe make twelve percent (12%) of its net annual State contribution to cities, towns or counties for government services that benefit the general public. Private, not-for-profit organizations wishing to access Indian Gaming Funds ("Gaming Funds") to provide public benefits must secure sponsorship from a city, town or county before making application. This sponsorship must be expressed in a resolution passed by the local government sponsor.

Section 2: The Salt River Pima-Maricopa Indian Community wishes the City of Mesa to receive and distribute **\$895,000.00** from its 2022 12% revenues for grants as follows:

- \$200,000.00 to **A New Leaf** for homeless and domestic shelter services.
- \$ 50,000.00 to **U.S. Vets – Phoenix** to support mental health services for homeless and at-risk veterans. Funding would be used to expand services in Maricopa County.
- \$ 75,000.00 to the **Child Crisis Center** for the Keeping Children Safe through Education program. Programming will focus on three primary areas: Family Education, Safe Kids Maricopa, and the FANS distribution center.
- \$ 50,000.00 to **Alice Cooper's Solid Rock Teen Center** for the Healthier Youth – with Smoothies program. The goal is to continue the education of youth for better nutritional habits.
- \$ 20,000.00 to **Visit Mesa** for the Fresh Foodie Trail – Agritourism in Arizona, Culinary Tourism Marketing Campaign.
- \$125,000.00 to the **United Food Bank** for the Emergency Food Assistance Produce Box Program.
- \$300,000.00 to the **City of Mesa** for five governmental programs.
- \$ 75,000.00 to the **Arizona Museum of Natural History** for the development of the Sonoran Desert's First Peoples exhibit.

Section 3: The City Council supports these grants and authorizes the City Manager, or his designee, to accept and administer the 2022 awarded Salt River Pima-Maricopa Indian Community Proposition 202 funding.

Section 4: Approval by the City Attorney or designee and signature by the City Manager or designee of the Intergovernmental Agreement, and any related amendments or supplements thereto, shall constitute conclusive evidence of this City Council's approval thereof.
