A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, APPROVING AND AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO ENTER INTO AN AGREEMENT WITH A NEW LEAF, INC. REQUIRING A NEW LEAF, INC. TO PROVIDE TEMPORARY HOUSING AND OTHER PROGRAMS AND SERVICES AT THE EAST VALLEY MEN'S CENTER TO MESA MEN WHO ARE EXPERIENCING HOMELESSNESS AND WHO ARE IN RECOVERY, AS PROVIDED FOR IN THE AGREEMENT, AND WHICH WILL BE FUNDED BY CORONAVIRUS STATE AND LOCAL FISCAL RECOVERY FUNDS.

WHEREAS, the American Rescue Plan Act of 2021 ("ARPA") established the Coronavirus State and Local Fiscal Recovery Funds ("ARPA Funds"), appropriating \$350 billion dollars to eligible state, local, territorial, and tribal governments to respond to the public health and economic impacts of the Coronavirus Disease 2019 public health emergency ("COVID-19").

WHEREAS, the City received ARPA Funds that can be used in accordance with the requirements of ARPA to provide assistance to communities impacted by COVID-19 and to provide emergency housing assistance and other emergency programs and services for people experiencing homelessness.

WHEREAS, the City wishes to transfer ARPA Funds to A New Leaf, Inc., an Arizona non-profit corporation, to assist the City in responding to COVID-19 and its negative economic impacts and to provide assistance to impacted communities by providing emergency housing assistance and other emergency programs and services for men experiencing and recovering from homelessness.

WHEREAS, the City desires to enter into the Coronavirus State and Local Fiscal Recovery Funds Mesa Subrecipient Agreement ("Agreement") with A New Leaf, Inc. requiring A New Leaf, Inc. to provide emergency housing and other emergency programs and services to Mesa men experiencing homelessness and to increase the number of Mesa men served at the East Valley Men's Center by 40 percent during the term of the Agreement, resulting in at least 175 Mesa men served at the East Valley Men's Center during the term of the Agreement, as provided for in the Agreement.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

<u>Section 1</u>: The City Council of the City of Mesa approves the Coronavirus State and Local Fiscal Recovery Funds Mesa Subrecipient Agreement ("Agreement") with A New Leaf, Inc. in the form of the Agreement provided to City Council.

Section 2: The City Manager or his designee is authorized and directed to enter into the Agreement and any related amendments, modifications, or supplements thereto, on behalf of the City of Mesa, together with all other documents necessary to carry out the provisions of the Agreement, and the City Clerk is authorized and directed to attest to the signature of the City Manager or his designee thereon.
