Subject:	Use of a Cooperative Contract for the Purchase of Four (4) Crew Trucks with Utility Service Bodies for the Energy Resources and Water Resources Departments (Funded by the Capital Utility and Utility Replacement Extension and Renewal Funds) (Citywide)

Recommendation

Council is requested to approve the award as recommended.

The Fleet Services, Energy Resources, and Water Resources Departments and Purchasing recommend authorizing the purchase using the State of Arizona cooperative contract with Freightliner of Arizona for \$1,093,339.84.

Background / Discussion

This purchase will provide four (4) Crew Trucks with Freightliner chassis with utility service bodies; two (2) additions for Energy Resources, and two (2) replacements for Water Resources. The vehicles that are being replaced have met established criteria and will be either traded, auctioned, sold, or deployed for special uses.

The City has standardized our fleet in which Freightliner has been able to standardize crew trucks to meet our specifications in all categories. Our in-house technicians can repair Freightliner trucks which provide cost-savings and time-savings for the City compared to sending the vehicles out for repairs.

The State of Arizona cooperative contract has been competitively bid and meets the City's procurement requirements. Utilizing the State of Arizona contract would allow the City to receive very competitive rates based on a formally solicited agreement. The City believes the pricing is fair and reasonable and soliciting for these vehicles would not result in the City receiving more favorable pricing or terms. Freightliner of AZ confirmed that both the State and Maricopa County contracts provide the same pricing.

The manufacturing order windows have been severely shortened due to microchip and supply chain shortages. The State of Arizona contract allows the City to purchase Crew Trucks, deliverable within 8 to 12 months. If the City competitively bids, it will take 18 to 24 months to manufacture the vehicles.
