A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA, APPROVING AND AUTHORIZING THE SUBMITTAL OF THE CITY OF MESA HOME INVESTMENT PARTNERSHIPS PROGRAM AMERICAN RESCUE **PLAN** (HOME-ARP) ALLOCATION PLAN FOR FY 2021/2022, AUTHORIZING THE SUBMITTAL OF THE HOME-ARP ALLOCATION PLAN TO RECEIVE HOME-ARP FUNDS UNDER THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) HOME INVESTMENT **PARTNERSHIPS PROGRAM** AMERICAN RESCUE ACT (HOME-ARP), AND AUTHORIZING DISBURSEMENT AND **EXPENDITURE** OF **FUNDS** RECEIVED.

WHEREAS, proposed activities to be undertaken were advertised and hearings held in order to inform Mesa citizens and receive comments regarding use of funds to be undertaken from fiscal year 2021/2022 HOME-ARP funds available under the following United States Department of Housing and Urban Development ("HUD") programs: (a) appropriated under section 3205 of the American Rescue Plan Act of 2021 (P.L. 117-2) ("ARP") for the HOME Investment Partnerships Program (HOME).

WHEREAS, the City Council was provided with recommendations of activities to be funded under HOME-ARP and has approved uses of funds.

WHEREAS, a proposed statement of the projected use of funds was completed in accordance with federal requirements and made available to the public.

WHEREAS, to receive the HOME-ARP fiscal year 2021/2022 funds, the City is required to submit to HUD a HOME-ARP Allocation Plan for fiscal year 2021/2022 ("Allocation Plan").

WHEREAS, the proposed HOME-ARP use of funds to be undertaken meet the objectives and priorities as identified in the 2020-2024 HUD Five-Year Consolidated Plan.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MESA, ARIZONA, AS FOLLOWS:

Section 1: The Allocation Plan is approved and the City Manager or his designee is authorized to sign and submit all necessary documents to HUD for the Allocation Plan.

<u>Section 2</u>: That the City Manager or his designee is authorized to sign and submit any modifications or revisions to the documents authorized under Section 1 above, without the further consent of the City Council; provided, however, that all said modifications or revisions are deemed necessary by HUD and are not a formal amendment required by HUD or applicable federal regulation to receive specific City Council approval.

Section 3: That the City Manager or his designee is hereby authorized to prepare, sign, and submit applications, as well as any other necessary documents, to HUD for the City of Mesa to receive fiscal year 2021/2022 HOME-ARP funds for uses approved by the City Council.

Section 4: That the City Manager or his designee is authorized to sign and submit any amendments, modifications, or revisions to the documents authorized under Section 3 above, without the further consent of the City Council, provided all said amendments, modifications, or revisions are in compliance with recommended uses of the City Council, the City's 2020-2024 HUD Five-Year Consolidated Plan, and the applicable federal program regulations.

<u>Section 5</u>: That the City Manager or his designee is authorized to expend and disburse the HOME-ARP program funds for activities approved by City Council.
