Subject: One-Year Renewal Contract for Advanced Traffic Controllers and Software

for the Transportation Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Renewal Contract for Advanced Traffic Controllers and Software as recommended.

The Transportation Department and Purchasing recommend authorizing the renewal with Clark Electric Sales, Inc. dba Clark Transportation Solutions; and Advanced Traffic Solutions, LLC dba Fourth Dimension Traffic; cumulatively not to exceed \$120,000.00, based on estimated requirements.

Background / Discussion

This contract provides the Linux-based Advanced Traffic Controllers (ATC), a newer controller standard that will replace the current standard the City has been using for over 20 years, and D4 controller firmware (software) that runs on the controllers that has advanced light rail transit features absent in other software options. This equipment has been deployed at signalized-intersections in the light rail corridor to take advantage of the advanced features and will likely expand to other signalized locations throughout the City.

On April 18, 2016, Council approved the initial one-year term which was the term period identified in the solicitation. This amendment will renew the contract for one year (4/18/2017 through 4/17/2018). There is a one-year renewal option remaining.

Alternatives

Council may choose not to authorize the one-year renewal contract and new responses will be solicited.

The annual contract amount is available in the Transportation Department operating budget.
